## A BILL FOR AN ACT

RELATING TO DRUG PRICING IN WORKERS' COMPENSATION AND MOTOR VEHICLE INSURANCE CLAIMS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's current
- 2 reimbursement rates for pharmaceuticals in workers' compensation
- 3 and motor vehicle claims are among the highest in the nation for
- 4 both brand name and generic products. The legislature further
- 5 finds that regulating the pricing of prescription medications
- 6 will help control the cost of prescription drugs and compound
- 7 medications in Hawaii's workers' compensation and motor vehicle
- 8 insurance systems.
- **9** The purpose of this Act is to limit reimbursement of
- 10 prescription medications in order to prevent drug prices from
- 11 becoming an unreasonable cost driver of health care in workers'
- 12 compensation and motor vehicle claims.
- 13 Motor vehicle personal injury protection charges follow the
- 14 workers' compensation medical fee schedule. Therefore, motor
- 15 vehicle insurance benefits shall automatically adopt the drug
- 16 pricing protections afforded in this Act unless otherwise

- 1 modified by the insurance commissioner through rulemaking
- 2 authority subsequent to the enactment of this Act.
- 3 SECTION 2. Chapter 386, Hawaii Revised Statutes, is
- 4 amended by adding a new section to be appropriately designated
- 5 and to read as follows:
- 6 "§386- Prescription drugs; pharmaceuticals. (a)
- 7 Notwithstanding any other provision to the contrary, immediately
- 8 after a work injury is sustained by an employee and so long as
- 9 reasonably needed the employer shall furnish to the employee all
- 10 prescription drugs as the nature of the injury requires. The
- 11 liability for the prescription drugs shall be subject to the
- 12 deductible under section 386-100.
- 13 (b) Payment for all forms of prescription drugs including
- 14 repackaged and relabeled drugs shall not exceed one hundred
- 15 forty per cent of the average wholesale price set by the
- 16 original manufacturer of the dispensed prescription drug as
- 17 identified by its national drug code and as published in the Red
- 18 Book: Pharmacy's Fundamental Reference as of the date of
- 19 dispensing; provided that payment for a prescription drug that
- 20 is not available at a major retail pharmacy within the State
- 21 shall not exceed one hundred per cent of the average wholesale
- 22 price set by the original manufacturer of the dispensed

- 1 prescription drug as identified by its national drug code and as
- 2 published in the Red Book: Pharmacy's Fundamental Reference as
- 3 of the date of dispensing.
- 4 (c) Payment for compounded medications shall not exceed
- 5 one hundred forty per cent of the average wholesale price by
- 6 gram weight of each underlying prescription drug contained in
- 7 the compound medication. For compounded medications, the
- 8 average wholesale price shall be that set by the original
- 9 manufacturer of the underlying prescription drug as identified
- 10 by its national drug code and as published in the Red Book:
- 11 Pharmacy's Fundamental Reference as of the date of compounding.
- 12 (d) If the original manufacturer of the underlying drug
- 13 product used in repackaged or relabeled drugs or compounded
- 14 medications is not provided or is unknown, then reimbursement
- 15 shall not exceed one hundred forty per cent of the average
- 16 wholesale price for the original manufacturer's national drug
- 17 code number as listed in the Red Book: Pharmacy's Fundamental
- 18 Reference of the prescription drug that is most closely related
- 19 to the underlying drug product.
- (e) Equivalent generic drug products shall be substituted
- 21 for brand name pharmaceuticals unless the prescribing physician

- 1 certifies no substitution is permitted because the injured
- 2 employee's condition will not tolerate a generic preparation.
- 3 (f) For purposes of this section:
- 4 "Equivalent generic drug product" has the same meaning as
- 5 provided in section 328-91.
- 6 "Major retail pharmacy" means a retail pharmacy with five
- 7 or more physical locations in the State and ten or more physical
- 8 locations in other states."
- 9 SECTION 3. New statutory material is underscored.
- 10 SECTION 4. This Act shall take effect upon its approval.
