## A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYEES.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 253, Session Laws of Hawaii 2000, and Act
2	300, Session Laws of Hawaii 2006, sought to reduce the number of
3	civil service exempt employees in public service in the State.
4	The legislature finds that since the enactment of these Acts,
5	there have been few conversions of civil service exempt
6	positions to civil service positions. The legislature further
7	finds that these conversions are overdue.
8	Accordingly, the purpose of this Act is to further the
9	purposes enumerated in the state plan in section 226-27, Hawaii
10	Revised Statutes, to ensure effective, efficient, and responsive
11 .	government service at all levels of the State and to ensure
12	fiscal integrity, responsibility, and efficiency in the state
13	and county governments by requiring the state auditor to:
14	(1) Review the current civil service exemption process;
15	and
16	(2) Recommend procedures, guidelines, and criteria to

extraordinary circumstances.

1	SECTION 2. (a) The state auditor shall review the current
2	civil service exemption processes in sections 46-33, 76-16, and
3	76-77, Hawaii Revised Statutes, and recommend procedures,
4	guidelines, and criteria to ensure that the civil service
5	exemption process is used appropriately and only in
6	extraordinary circumstances.
7	(b) The state auditor shall:
8	(1) Determine the reasons state and county departments and
9	agencies have used the civil service exemption
10	process; and
11	(2) Recommend modifications to streamline and update the

14	agencies to accurately reflect the duties that the
