RELATING TO PRIVATE GUARDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the purpose of Act 208, Session Laws of Hawaii 2010, was to ensure the competency 2 and professionalism of private security guards and individuals 3 acting in a guard capacity by requiring these individuals to 4 5 register as a guard with the board of private detectives and quards ("board") and meet new registration, instruction, and 6 training requirements prior to actin0g as a guard. 7 8 The legislature further finds that, as the board has just 9 completed the initial registration of approximately nine **10** thousand guard employees in 2013, the board, industry, and registrants need some relief from the continuing education 11 requirement that is scheduled to go into effect on June 30, 12 Accordingly, the effective date of the new continuing 13 education requirements should be extended to the next renewal 14 15 period of June 30, 2016.

The legislature additionally finds that although the board

4	by this section, pass a written test, and undergo four hours of

7	or who has otherwise been approved by the board for on-the-job
8	training. Guards and individuals acting in a guard capacity
9	shall successfully complete:
10	(1) Eight hours of classroom instruction before the first
11	day of service; and
12	(2) Four hours of classroom instruction [annually]
13	biennially thereafter[-]; provided that in addition to
14	relevant guard industry material, the required
15	classroom instruction shall include a refresher
16	component on professional image and aloha training."
