BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 281, Session Laws of Hawaii 2013, section 2 2, is amended by amending subsections (a) and (b) to read as 3 follows: 4 "(a) The comptroller and the state foundation on culture 5 and the arts shall commission a permanent [+ three-dimensional] 6 work of art to portray the life, vision, accomplishments, impact, and legacy of the late United States Senator Daniel K. 7 8 Inouye so as to properly honor his memory and to utilize his 9 example as an inspiration for current and future generations. (b) 10 The state foundation on culture and the arts, at the 11 earliest opportunity, shall issue a call for design entries; 12 provided that the design [shall include but] is not limited to a 13 likeness of Daniel K. Inouye [at some stage of his life]." 14 SECTION 2. Act 281, Session Laws of Hawaii 2013, section 15 3, is amended by amending subsection (b) to read as follows: 16 "(b) The state foundation on culture and the arts, at the
