

## A BILL FOR AN ACT

RELATING TO HOUSING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 247-7, Hawaii Revised Statutes, is			
2	amended to read as follows:			
3	"§247-7 Disposition of taxes. All taxes collected under			
4	this chapter shall be paid into the state treasury to the credit			
5	of the general fund of the State, to be used and expended for			
6	the purposes for which the general fund was created and exists			
7	by law; provided that of the taxes collected each fiscal year:			
8	(1) Ten per cent shall be paid into the land conservation			
9	fund established pursuant to section 173A-5;			
10	(2) Twenty-five per cent from July 1, 2009, until June 30,			
11	2012, and thirty per cent in each fiscal year until			
12	June 30, 2014, [thereafter] shall be paid into the			
13	rental housing trust fund established by section 201H-			
14	202; [ <del>and</del> ]			
15	(3) per cent from July 1, 2014, and in each fiscal			
16	year thereafter shall be paid into the rental housing			
17	trust fund established by section 201H-202; and

- 3 SECTION 3. There is appropriated out of the rental housing
- 4 trust fund the sum of \$ or so much thereof as may be
- 5 necessary for fiscal year 2014-2015 to promote a significant
- 6 increase in new affordable rental housing units.
- 7 The sum appropriated shall be expended by the Hawaii
- 8 housing finance and development corporation for the purposes of
- 9 this Act.
- 10 SECTION 4. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 5. This Act shall take effect on July 1, 2014.
