BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 342G-104, Hawaii Revised Statutes, is amended to read as follows: 2 3 "§342G-104 Deposit into deposit beverage container deposit special fund; use of funds. (a) There is established in the 4 5 state treasury the deposit beverage container deposit special 6 fund, into which shall be deposited: 7 (1)All revenues generated from the deposit beverage container fee as described under sections 342G-102 and 8 9 342G-105; 10 (2) All revenues generated from the deposit beverage 11 container deposit as described under sections 342G-105 12 and 342G-110; and 13 (3) All accrued interest from the fund.
- (5) All accrued interest from the fund.
- (b) Moneys in the deposit beverage container deposit
 special fund shall be used to reimburse refund values and pay
 handling fees to redemption centers. The department may also
