A BILL FOR AN ACT

RELATING TO CONTINUING COMPETENCY FOR NURSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that to ensure public
 protection, candidates for initial nurse licensure are required
- 3 to pass a national examination that measures the minimum
- 4 competencies needed to perform safely and effectively as newly
- 5 licensed, entry-level registered or practical nurses. In
- 6 today's health care environment, because technology and practice
- 7 are continually changing and new health care systems are
- 8 emerging, the challenge of licensure boards is to assure
- 9 consumers that nurses are competent throughout their practice
- 10 careers. Research shows that continuing education alone is not
- 11 enough to ensure competency in post-entry nurses. According to
- 12 the Institute of Medicine, "[A]n emerging concept ... includes
- 13 components of [continuing education] but has a broader focus,
- 14 such as teaching how to identify problems and apply solutions,
- 15 and allowing health professionals to tailor the learning
- 16 process, setting, and curriculum to their needs."
- 17 The legislature further finds that continuing competency
- 18 that ensures continued patient health and safety requires



- 1 lifelong learning and ongoing redefinition based on the
- 2 individual's experience, change in practice setting, and
- 3 educational advancement. Each nurse must maintain and augment
- 4 the necessary knowledge and skills to be current in practice. To
- 5 do this, each nurse needs a self-assessment tool that enables
- 6 the nurse to: assess and adapt to their learning needs; stretch
- 7 learning from the classroom to the point of care; match the need
- 8 for continuing education to the learning for competence; and
- 9 support increased personal accountability for lifelong learning
- 10 to ensure safe practice.
- 11 The legislature therefore finds that the Hawaii nurse
- 12 continued competency program, which contains these elements and
- 13 learning activity options, must be established for nurses
- 14 licensed in Hawaii.
- Accordingly, the purpose of this Act is to require licensed
- 16 registered nurses and licensed practical nurses to submit
- 17 evidence of continuing competency at each renewal period,
- 18 beginning with the June 30, 2015, licensing biennium.
- 19 SECTION 2. Chapter 457, Hawaii Revised Statutes, is
- 20 amended by adding five new sections to be appropriately
- 21 designated and to read as follows:

3	<u>(c)</u>	Upon application for license renewal or reinstatement,
4	each lice	nsee shall attest to completion of one of the learning
5	activity	options pursuant to subsection (d) during the two years
6	preceding	the application for license renewal and shall be
7	prepared	to submit evidence of completion if requested by the
8	board.	
9	<u>(d)</u>	Completion of one of the following learning activities
10	shall mee	t the requirements for continuing competence under
11	subsectio	n (a):
12	(1)	National certification or recertification related to
13		the nurse's practice role;
14	(2)	Thirty contact hours of continuing education
15		activities;
16	(3)	Completion of a board approved refresher course;
17	(4)	Completion of a minimum of two semester hours of post-
18		licensure academic education related to nursing
19		practice;
20	<u>(5)</u>	Fifteen contact hours of a continuing education
21		activity and completion of a nursing research or

1		evidence-based practice project as principal or co-
2		principal investigator;
3	<u>(6)</u>	Fifteen contact hours of a continuing education
4		activity and authoring or coauthoring a peer reviewed
5		published nursing or health-related article, paper,
6		book, or book chapter;
7	(7)	Fifteen contact hours of a continuing education
8		activity and developing and conducting a nursing
9		education presentation or presentations totaling a
10		minimum of five contact hours;
11	<u>(8)</u>	Fifteen contact hours of a continuing education
12		activity and six hundred forty hours of active
13		practice within the previous two years; or
14	(9)	Completion of a recognized nurse residency program.
15	(e)	The following activities do not meet the requirements
16	for contin	nuing competency:
17	(1)	Offerings designed for lay persons;
18	(2)	Offerings less than thirty minutes in duration;
19	(3)	On-the-job orientation;
20	(4)	On-the-job training related to new policies,
21		procedures, or equipment; or

1	(5)	Other educational activities not sufficiently
2		professional in character to reasonably qualify as
3		continuing education.
4	(f)	Acceptable documentation for completion of the
5	learning	activities under subsection (d) includes the following
6	evidence:	
7	(1)	For national certification: a copy of a certificate
8		that includes the name of the licensee, name of the
9		certifying body, date of certification, and date of
10		certification expiration. Certification shall be
11		initially attained during the licensure period, have
12		been in effect during the entire licensure period, or
13		have been recertified during the licensure period;
14	(2)	For contact hours of continuing education: the name
15		of the licensee, title of educational activity, name
16		of the provider, number of contact hours, and date of
17		activity;
18	(3)	For a board approved refresher course: written
19		correspondence from the provider with the name of the
20		licensee, name of the provider, and verification of
21		successful completion of the refresher course;

1	(4)	for post-licensure academic education: a copy of the
2		licensee's transcript with the name of the licensee,
3		name of the educational institution, dates of
4		attendance, name of course with grade, and number of
5		credit hours received. Coursework shall demonstrate
6		relevance to nursing, health, or both;
7	(5)	For a nursing project: an abstract or summary of the
8		project, the name of the licensee, role of the
9		licensee as principal or co-principal investigator,
10		date of project completion, statement of the problem,
11		project objectives, methods used, and summary of
12		<pre>findings;</pre>
13	<u>(6)</u>	For authoring or co-authoring a peer reviewed
14		published nursing-related article, paper, book, or
15		book chapter: a copy of the publication, including
16		the name of the licensee and the publication date;
17	<u>(7)</u>	For developing and conducting an educational
18		presentation or presentations totaling at least five
19		contact hours for nurses or other health
20		professionals: a copy of the program brochure or
21		course syllabi, objectives, content, and teaching
22		methods, and date and location of presentation; and

1	(8)	For six hundred forty hours of active practice in
2		nursing: name of the licensee, number of hours worked
3		in a calendar or fiscal year, name and address of the
4		employer, and signature of supervisor. If self-
5	•	employed, hours worked may be validated through other
6		methods, such as tax records or other business
7		records. If active practice is of a volunteer or
8		gratuitous nature, hours worked may be validated by
9		the recipient agency.
10	<u>(g)</u>	Each licensee shall retain supporting documentation to
11	meet the	requirements for completion of continuing competence
12	under sub	section (a) for a period of four years after the course
13	or activi	ty concludes.
14	(h)	At the time of license renewal or reinstatement,
15	<u>licensees</u>	may be subject to audit for proof of compliance with
16	the board	's requirements for continuing competence.
17	(i)	The board may randomly audit a licensee's continuing
18	competenc	e units and may establish guidelines for random audits.
19	The board	shall inform licensees of the licensees' selection for
20	audit upo	n notice of license renewal or reinstatement.
21	Documenta	tion of acceptable evidence shall be consistent with

¥	subsection (1) and shall be submitted to the board no later than
2	the last day of the renewal month.
3	(j) Unless exempted, failure of a licensee to meet
4	continuing competency requirements shall result in disciplinary
5	action in accordance with this chapter. Failure to present
6	evidence of compliance to the board upon request shall
7	constitute a forfeiture of the license.
8	§457- Authorized providers of continuing competence
9	units. (a) Continuing education may be taken in a conventional
10	classroom setting, via online courses, professional journals,
11	correspondence, or other emerging venues.
12	(b) Continuing competence units shall be obtained from the
13	following authorized providers:
14	(1) Any provider, recognized by a national credentialing
15	body, offering certification in the licensed nurse's
16	specialty area of practice, including but not limited
17	to: American Nurses Credentialing Center Commission
18	on Certification; Oncology Nursing Certification
19	Corporation; Board of Certification for Emergency
20	Nursing; National Association for Practical Nurse
21	Education and Service, Inc.; and National Commission
22	for Health Education Credentialing, Inc.;

1	(2)	Any provider, recognized by a national credentialing
2		body, offering certification to nurse practitioners,
3		nurse midwives, nurse anesthetists, or clinical nurse
4		specialists, including but not limited to: American
5		Nurses Credentialing Center Commission on
6		Certification; American Academy of Nurse
7		Practitioners; National Certification Corporation;
8		Pediatric Nursing Certification Board; and Council on
9		Certification of Nurse Anesthetists;
10	(3)	American Nurses Association, or any state professional
11		nurses association with standards equal or greater
12		than the State's standards;
13	(4)	Area Health Education Centers in the State or any
14		state Area Health Education Center that is a member of
15		the National Area Health Education Center
16		Organization;
17	(5)	National League for Nursing;
18	<u>(6)</u>	National Association for Practical Nurse Education and
19		Service, Inc.;
20	<u>(7)</u>	National Federation of Licensed Practical Nurses;
21	(8)	Any state board of nursing with standards equal to or
22		greater than the State's standards;

(9)	National Council of State Boards of Nursing;
(10)	Employer-sponsored continuing education programs
	having a minimum of one course objective; provided
	that employer-sponsored continuing education may only
	be used for up to fifty per cent of total contact
	hours unless the program is accredited through one of
	the authorized providers in this subsection;
(11)	Any provider of professional continuing education for
	health care professionals recognized by the board,
	with offerings related to specialty areas of nursing
	practice such as research, case management, health
	policy, forensics, mental health, or complementary
	alternative therapies offered by entities including
	but not limited to the Commission for Case Manager
	Certification, National Association for Healthcare
	Quality, or American Legal Nurse Consultant
	Certification Board;
(12)	Professional journals such as American Journal of
	Nursing, Nursing 2006, Nursing Management, Journal of
	Practical Nursing, and The Nurse Practitioner,

4	<u>§457</u>	- Exemption from continuing competence requirements.
5	(a) Prio	r to the expiration of a renewal period, a licensee may
6	submit a	written request to the board for an exemption from the
7	continuin	g competence requirements in this chapter.
8	(b)	The request for an exemption shall include evidence
9	that, dur	ing the two-year period prior to the expiration of the
10	license:	
11	(1)	The licensee was residing in another country for one
12		year or longer, reasonably preventing completion of
13		the continuing competence requirements;
14	(2)	The licensee was ill or disabled for one year or
15		longer as documented by a licensed physician, surgeon,
16		clinical psychologist, or advanced practice registered
17		nurse, preventing completion of the continuing
18		competence requirements; or
19	(3)	A dependent family member of the licensee was ill or
20		disabled for one year or longer as documented by a
21		licensed physician, surgeon, clinical psychologist, or

1	advanced practice registered nurse, preventing
2	completion of the continuing competence requirements.
3	(c) Exemptions shall be considered by the board on a case
4	by case basis. Exemptions shall not be granted unless proof,
5	deemed appropriate and sufficient by the board that the
6	applicant can practice safely, is submitted to the board.
7	Exemptions shall not be granted for more than one renewal
8	period. In the event a licensee cannot complete the continuing
9	competence requirements during the two-year period after
10	receiving an exemption, the licensee may only renew the license
11	on an inactive status.
12	(d) When a licensee is absent from the State because of
13	military service for a period of one year or longer during the
14	two-year renewal period, preventing completion of the continuing
15	competence requirement, the board may provide an exemption from
16	the continuing competence requirement for more than one renewal
17	period.
18	<u>§457-</u> Record keeping for continuing competence. (a)
19	Each licensee shall keep and maintain records showing that each
20	course or activity for which credit is claimed has been
21	completed.

1	(b) These records shall reflect the title of the course or
2	activity, the date taken or completed, and the record of
3	participation.
4	(c) Each licensee shall retain such documentation for a
5	period of four years after the course or activity concludes.
6	(d) Each licensee shall provide copies of such
7	documentation to the board or its designee within fourteen
8	calendar days after being requested to provide such
9	documentation.
10	§457- Continuing competence; continuing education units;
11	contact hours. (a) The following are acceptable contact hours
12	or continuing education units that fulfill the continuing
13	competence requirements of this chapter:
14	(1) One contact hour shall be equivalent to sixty minutes
15	of instruction;
16	(2) One contact hour shall be equivalent to sixty minutes
17	of clinical or laboratory practice in an informal
18	offering or a minimum of fifty minutes of actual
19	organized instruction;
20	(3) One continuing medical education unit shall be
21	equivalent to one contact hour of instruction; and

1	(4)	One continuing education unit shall be equivalent to
2		ten contact hours of instruction.
3	(b)	Academic credit shall be converted to contact hours as
4	follows:	
5	(1)	One quarter academic credit shall be equivalent to
6		twelve and a half contact hours; and
7	(2)	One semester academic credit shall be equivalent to
8		fifteen contact hours.
9	<u>(c)</u>	Contact hour equivalencies shall be as follows:
10	(1)	One continuing education unit shall be equivalent to
11		ten contact hours;
12	(2)	One continuing medical education credit shall be
13		equivalent to sixty minutes; and
14	(3)	One American Medical Association credit shall be
15		equivalent to sixty minutes."
16	SECT	ION 3. Section 457-2, Hawaii Revised Statutes, is
17	amended by adding three new definitions to be appropriately	
18	inserted and to read as follows:	
19	"_Competence" means the application of knowledge, skills,	
20	and behaviors required to function effectively, safely,	
21	ethically, and legally within the context of the individual's	
22	role and	environment.

1	"Continuing competence" means the lifelong process of
2	maintaining and documenting competence through ongoing self-
3	assessment, development, and implementation of a personal
4	learning plan, and subsequent reassessment.
5	"Unit" means a relative value assigned to continuing
6	competence activities in which one continuing competence unit is
7	equivalent to at least fifty minutes of classroom or hands on
8	instruction."
9	SECTION 4. New statutory material is underscored.
10	SECTION 5. This Act shall take effect upon its approval;
11	provided that the continuing competence requirements for
12	registered nurses and practical nurses shall take effect with
13	the licensing biennium beginning on June 30, 2015.
