### A BILL FOR AN ACT

RELATING TO EMPLOYMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 398, Hawaii Revised Statutes, is 1 2 amended by adding a new part to be appropriately designated and 3 to read as follows: "PART 5 PARTIAL WAGE REPLACEMENT FOR LEAVE Partial wage replacement for leave trust fund. \$398-A 7 There is established outside the state treasury, a trust 8 fund to be known as the "partial wage replacement for leave trust fund". 10 (b) The trust fund shall consist of employee 11 contributions, which shall not exceed per cent of each 12 employee's wages per pay period, as well as interest earned and 13 income, dividends, refunds, rate credits, and other returns 14 received by the fund. It is hereby declared that any and all 15 sums contributed or paid from any source to the fund created by 16 this part, and all assets of the fund including any and all 17 interest and earnings on the same, are and shall be held in 18 trust by the department for the exclusive use and benefit of the

- 1 employee-beneficiaries and shall not be subject to appropriation
- 2 for any other purpose whatsoever.
- 3 (c) The trust fund shall be used to provide an eligible
- 4 employee with twelve weeks per calendar year of paid family
- 5 leave; provided that an employee shall not be paid more than
- 6 sixty-six per cent of the employee's monthly wage.
- 7 (d) The trust fund shall be under the control of and
- 8 administered by the department.
- 9 (e) After fiscal year 2014-2015, the partial wage
- 10 replacement for leave trust fund shall become self-sustaining
- 11 through employee contributions.
- 12 §398-B Wage withholding. (a) Each employee shall make a
- 13 contribution to the partial wage replacement for leave trust
- 14 fund per pay period.
- 15 (b) If an employee's contribution to the fund is not
- 16 withheld and transmitted to the fund, the employee shall pay
- per cent of the employee's wage per pay period directly to
- 18 the fund by the first day of each month.
- 19 (c) The department of taxation shall administer and
- 20 oversee each employee's contribution to the partial wage
- 21 replacement for leave trust fund."

2	amended by amending the definition of "employer" to read as

5	the State, any of its political subdivisions, any

8	insurance company, or corporation, whether domestic or foreign,
9	or receiver or trustee in bankruptcy, or the legal
10	representative of a deceased person, who employs one [hundred]
11	or more employees for each working day during each of twenty or
12	more calendar weeks in the current or preceding calendar year."
13	SECTION 3. Section 398-3, Hawaii Revised Statutes, is
14	amended by amending subsection (a) to read as follows:
15	"(a) An employee shall be entitled to a total of $[four]$
16	<u>twelve</u> weeks of family leave during any calendar year [upon the
17	birth of a child of the employee or the adoption of a child, or
18	to care]:
19	(1) To care for or bond with the employee's child within
20	twelve months of the child's birth, foster placement,
21	or placement for adoption with the employee; or
