### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 291C, Hawaii Revised Statutes, is
2	amended by adding to part X a new section to be appropriately
3	designated and to read as follows:
4	"§291C- Speed limits for trucks, truck-trailer
5	combinations; and tractor-semitrailer combinations. (a) No
6	person shall drive any of the following motor vehicles on any
7	interstate highway at a speed exceeding ten miles per hour less
8	than the maximum speed limit established for all other motor
9	vehicles by official signs placed by the director of
10	transportation on interstate highways under the director's
11	jurisdiction:
12	(1) A truck having three or more axles;
13	(2) A truck-trailer combination; and
14	(3) A tractor-semitrailer combination.
15	(b) The director of transportation shall place signs on
16	interstate highways under the director's jurisdiction
17	establishing maximum speed limits for vehicles enumerated in

- 1 (c) For the purposes of this section, "interstate highway"
- 2 means interstate H-1, interstate H-2, interstate H-3, interstate
- 3 H-201, and route 78.
- 4 (d) Any person who violates subsection (a) by exceeding a
- 5 posted speed limit established under this section by fifteen
- 6 miles per hour or more shall be guilty of a misdemeanor and
- 7 shall be sentenced without the possibility of probation as
- 8 provided in section 291C-105.
- 9 (e) Any driver of a commercial motor vehicle holding a
- 10 commercial driver's license issued by this State who is
- 11 convicted of violating subsection (a) for excessive speeding
- 12 involving any single offense for any speed of fifteen miles per
- 13 hour or more above the posted speed limit shall be quilty of a
- 14 serious traffic violation, as defined in section 286-231.
- (f) For the purposes of this section, "commercial motor
- 16 vehicle", "truck", "truck-trailer combination", and "tractor-
- 17 semitrailer combination" shall have the same meanings as those
- 18 terms are defined in section 286-2."
  - 19 SECTION 2. This Act does not affect rights and duties that
  - 20 matured, penalties that were incurred, and proceedings that were
  - 21 begun before its effective date.
- 22 SECTION 3. New statutory material is underscored.
