A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 346, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§346- Chiropractic coverage under medical assistance
5	programs. (a) For purposes of medical assistance programs
6	including medicaid and QUEST Integration under section
7	346-14(7), chiropractic, as defined in section 442-1,
8	administered by a person licensed to practice chiropractic under
9	section 442-2, shall be covered; provided that:
10	(1) Chiropractic coverage under this section shall be
11	limited to twenty-four visits per calendar year; and
12	(2) The department may negotiate rates, or establish
13	payment and reimbursement rates, as appropriate.
14	(b) Notwithstanding any other law to the contrary, the
15	department shall make appropriate adjustments to the rate of
16	payment per participating recipient on amounts paid to health
17	maintenance organizations and prepaid health plans pursuant to
18	section 346-59(d), to allow for chiropractic coverage to QUEST

- 1 Integration recipients for chiropractic services as required by
- 2 this section. Health maintenance organizations and prepaid
- 3 health plans shall not be required to increase coverage to QUEST
- 4 Integration recipients for chiropractic coverage administered to

- 6 adjustments to the rate of payment per participating recipient
- 7 on amounts paid to health maintenance organizations and prepaid

- 9 SECTION 2. The department of human services shall submit a
- 10 request to the Centers for Medicare and Medicaid Services to
- 11 amend the state medicaid plan to add chiropractic services as a
- 12 benefit, pursuant to section 1 of this Act, to allow the State
- 13 to receive federal reimbursement. The department of human
- 14 services shall report to the legislature upon receiving a
- 15 response from the Centers for Medicare and Medicaid Services on
- 16 the requested amendment to the state medicaid plan.
- 17 SECTION 3. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2014-2015 for
- 20 the purposes of section 1 of this Act.
- 21 The sum appropriated shall be expended by the department of
- 22 human services for the purposes of this Act.
