A BILL FOR AN ACT

RELATING TO THE HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND BOARD OF TRUSTEES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the counties need
- 2 representation on the board of trustees of the Hawaii employer-
- 3 union health benefits trust fund. The counties contribute a
- 4 substantial amount to the fund, and the health and well-being of
- 5 their employees and retirees depend upon the benefit decisions
- 6 made by the board of trustees. Despite their lack of
- 7 representation as public employer, the counties are affected by
- 8 board decisions.
- 9 The purpose of this Act is to require that one of the five
- 10 seats on the board that are allocated to public employers be
- 11 occupied by a member appointed by the mayors of all four
- 12 counties and approved by the Hawaii State Association of
- 13 Counties.
- 14 SECTION 2. Section 87A-5, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- 16 "§87A-5 Composition of board. The board of trustees of
- 17 the employer-union health benefits trust fund shall consist of

6	Section 26-34 shall not apply to board member selection and			
7	terms. Notwithstanding any other provision of this section, no			
8	exclusive representative of a bargaining unit that sponsors or			
9	participates in a voluntary employee beneficiary association			
10	shall be eligible to select nominees or to be represented by a			
11	trustee on the board.			
12	As used in this section, the term "exclusive			
13	representative" shall have the same meaning as in section 89-2."			
14	SECTION 3. Statutory material to be repealed is bracketed			
15	and stricken. New statutory material is underscored.			
16	SECTION 4. This Act shall take effect upon its approval.
