A BILL FOR AN ACT

RELATING TO WORKFORCE DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii is the most
- 2 geographically isolated archipelago in the world and has an
- 3 economy that currently depends on very few and finite resources.
- 4 With an economy heavily dependent on the military and tourism,
- 5 developing dependable industries that will stabilize and grow
- 6 the economy is vital for the State's continued development.
- 7 Emerging industries and technologies, including renewable
- 8 energy, computer software development, and agriculture, if
- 9 properly developed with a home-grown workforce, would provide
- 10 continued stability and economic growth.
- 11 The legislature also finds that, to create conditions that
- 12 would energize the development of these new economic industries
- 13 in Hawaii, a partnership consisting of educational and
- 14 workforce/labor development sources would foster the private-
- 15 sector confidence necessary for investors to consider developing
- 16 new industries in Hawaii and ensure the hiring of residents who
- 17 have been educated in these high-skill, high-wage industries.

- 1 directed towards workforce development and training rely on work
- 2 groups consisting of representatives of specific targeted
- 3 industries, education, and the workforce community to help
- 4 identify emerging workforce trends, determine skills required,

- 7 through these work groups will be essential to leverage
- 8 workforce development efforts within these partnerships. The
- 9 involvement of a number of organizations that do business in
- 10 Hawaii and have common needs for workforce development,
- 11 technologies, and infrastructure will increase efficiency and

- 13 SECTION 2. Chapter 371, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "§371- Workforce development work groups; established.
- 17 (a) The department may establish work groups of industry
- 18 leaders in industries or occupations having potential for high
- 19 job growth to assist the department in identifying workforce
- 20 trends, determining skill sets required for jobs being created
- 21 or modified, and developing training to prepare qualified
- workers.

- 1 (b) The department shall include representatives on the
- 2 work groups from the education, post-secondary education,
- 3 workforce, and business communities, as appropriate, for
- 4 specific, targeted occupations or industries.
- 5 (c) The department may develop training programs to
- 6 address skill shortages and provide training in the skill sets
- 7 required for jobs in the occupations or industries identified by
- 8 the work groups."
- 9 SECTION 3. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$ or so much
- 11 thereof as may be necessary for fiscal year 2014-2015 for the
- 12 department of labor and industrial relations to establish work
- 13 groups and design and implement training programs in accordance
- 14 with this Act.
- 15 The sum appropriated shall be expended by the department of
- 16 labor and industrial relations for the purposes of this Act.
- 17 SECTION 4. New statutory material is underscored.
- 18 SECTION 5. This Act shall take effect on January 20, 2050.
