- 13 interest upon judgments against the State, payment of interest
- 14 shall be limited to the period from the date of judgment, if
- 15 applicable, to thirty days after the effective date of this Act,
- 16 as provided in section 662-8, Hawaii Revised Statutes, for those
- 17 cases to which the statute applies.
- 18 SECTION 5. All unexpended and unencumbered balances of the
- 19 appropriations made in this Act as of the close of business on
- 20 June 30, 2015, shall lapse.
- 21 SECTION 6. If any provision of this Act, or the
- 22 application thereof to any person or circumstance, is held
