## A BILL FOR AN ACT

RELATING TO THE HAWAIIAN LANGUAGE IMMERSION PROGRAM.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaiian language, the native language of 2 the Native Hawaiian people, was once a thriving language used by 3 Native Hawaiians and foreigners alike. However, by the late twentieth century, the Hawaiian language was pushed to the brink 4 5 of extinction due to a number of factors, including an 1896 law 6 that functioned to ban the speaking of the Hawaiian language in 7 Hawai'i schools. Fortunately, the Hawaiian language was saved by 8 several historic initiatives, including the department of 9 education's Hawaiian language immersion program, which was **10** Today, the Hawaiian language immersion launched in the 1980s. 11 program is offered at twenty-one public schools and educates 12 more than two thousand students in kindergarten through the 13 twelfth grade. 14 The assessment requirements of the No Child Left Behind Act 15 of 2001 present a challenge for the Hawaiian language immersion 16 program. Because English is not formally introduced in Hawaiian

language immersion program classrooms until the fifth grade,

- 1 language to comply with the requirements of the No Child Left
- 2 Behind Act. During the 2005-2006 and through the 2010-2011
- 3 school years, these students have been taking the Hawaiian
- 4 aligned portfolio assessment, which was developed in the
- 5 Hawaiian language specifically for the Hawaiian language
- 6 immersion program, to comply with the requirements of the No
- 7 Child Left Behind Act.
- 8 The legislature finds that the Hawaiian language is a
- 9 critical component of the heritage of the State of Hawai'i, and
- 10 that the State has a solemn obligation to perpetuate the
- 11 Hawaiian language. For example, the Hawai'i state constitution
- 12 recognizes the Hawaiian language as one of two official
- 13 languages of the State. Moreover, the board of education has
- 14 adopted a policy, Board of Education Policy 2105, acknowledging
- 15 that its Hawaiian language immersion program is "an essential
- 16 component to the revitalization and continuation of the Hawaiian
- 17 language and culture." The policy further states that one of
- 18 the goals of the Hawaiian language immersion program is to set a
- 19 challenging curriculum that follows the Hawaii content and
- 20 performance standards.
- 21 Furthermore, the federal Native American Languages Act of
- 22 1990 recognizes the United States' responsibility to ensure the

- 1 survival of Native American languages and establishes the
- 2 nation's policy of encouraging and supporting the use of Native
- 3 American languages as a medium of instruction to help preserve
- 4 those languages.
- 5 The legislature further finds that to uphold its obligation
- 6 to perpetuate the Hawaiian language, the department of education
- 7 must provide the students of the Hawaiian language immersion
- 8 program with an assessment system that most accurately measures
- 9 their academic achievement.
- 10 The purpose of this Act is to require the department of
- 11 education to develop annual assessments in the Hawaiian language
- 12 in language arts, mathematics, and science to be administered to
- 13 students in grades three through six of the department of
- 14 education's Hawaiian language immersion program.
- 15 SECTION 2. The Hawaii Revised Statutes is amended by
- 16 adding a new chapter to be appropriately designated and to read
- 17 as follows:
- 18 "CHAPTER
- 19 HAWAIIAN LANGUAGE IMMERSION PROGRAM
- 20 § -1 Assessments. (a) The department of education, for
- 21 purposes of educational accountability under the Elementary and

- 1 Secondary Education Act of 1965, as amended, shall develop
- 2 annual assessments in the Hawaiian language:
- 3 (1) In language arts and mathematics, to be administered
- 4 to Hawaiian language immersion program students in
- 5 grades three through six; and
- 6 (2) In science, to be administered to Hawaiian language
- 7 immersion program students in grade four.
- 8 The assessments shall be administered annually commencing with
- **9** the 2015-2016 school year.
- 10 (b) The assessments shall not be Hawaiian translations of
- 11 the general state assessments and shall be:
- 12 (1) Aligned with the vision, mission, and programmatic
- goals of the Hawaiian language immersion program;
- 14 (2) Aligned with applicable state academic content and
- 15 achievement standards;
- 16 (3) Valid, reliable, and consistent with relevant,
- 17 nationally recognized professional and technical
- 18 standards; and
- (4) Compliant with federal requirements.
- (c) All ancillary assessment materials and tools that are
- 21 made available to students taking the general state assessment
- 22 shall also be made available in the Hawaiian language to

students in the Hawaiian language immersion program to the 1 2 extent that these materials and tools can be adapted for use in 3 the Hawaiian language. The department of education shall work 4 with the Hawaiian language community and any contractor to develop the ancillary materials and tools required under this 5 6 subsection. Such materials and tools shall be comparable to 7 those developed for Smarter Balanced Assessment Consortium assessments aligned with the common core state standards. 8 9 The department of education, with the assistance of 10 the Hawaiian language community, including the 'Aha Kauleo 11 Kaiapuni Hawai'i, members of the Hawaiian language immersion 12 program schools, the Hawaiian language programs at the 13 University of Hawaii at Hilo and the University of Hawaii at 14 Manoa, the office of Hawaiian affairs, and other Hawaiian 15 language community organizations, shall establish procedures for the development of the assessments specified in subsection (a)." 16 17 SECTION 3. The department of education shall report to the legislature on the status of the procedures for the development **18** 19 of assessments in the Hawaiian language, pursuant to section 20 -1, Hawaii Revised Statutes, including the estimated costs 21 and other critical resources or agreements for the development

- 1 of the assessments, no later than twenty days prior to the
- 2 convening of the regular session of 2014.
- 3 SECTION 4. This Act shall take effect upon its approval.
