JUSTIFICATION SHEET

DEPARTMENT: Office of the Governor

TITLE: A BILL FOR AN ACT RELATING TO HIGH TECHNOLOGY.

PURPOSE: To diversify Hawaii's economy, a high technology transfer bridge to manufacturing is needed to support our local tech industry. This Act will broaden the existing program to include funding at Phase II or Phase III stages. Also increases the ceiling on transfers from the Hawaii capital loan revolving fund from \$100,000 to \$500,000.

MEANS: Amend section 206M-15 (b) and (d), Hawaii Revised Statutes.

JUSTIFICATION: The high technology transfer bridge to manufacturing will build upon Hawaii's SBIR grant program and fill a critical gap in funding new ideas and technologies to enter the marketplace. Ultimately this will result in the growth of the high technology industry and the launch of new economic sources and intellectual property and innovation in Hawaii.
