#### JUSTIFICATION SHEET

DEPARTMENT: Labor and Industrial Relations

TITLE: A BILL FOR AN ACT RELATING TO PREVAILING

WAGE CONTRACTOR PENALTIES.

PURPOSE: To ensure that contractors do not unfairly

bid or deprive workers of statutorily required wages on public works construction projects by increasing existing penalties as

follows: (1) to immediately suspend a contractor for interference and delay and falsification of records; (2) to increase

the length of suspension for a third violation, falsification of records or for delay or interference with an investigation

from three to five years; and (3) to have the director issue notification of suspensions to include the governmental

contracting agency, and the general contractor in the case of suspended

subcontractor.

MEANS: Amend sections 104-24(c), 104-25(a), and

104-25(b), Hawaii Revised Statutes (HRS).

JUSTIFICATION: The foundation of chapter 104, HRS, is to

create a fair and equitable playing field for contractors who bid on public works construction projects. This chapter requires that contractors comply with prevailing wage, overtime, record keeping and other provisions that keep the labor costs equal, and that completion of work to be performed be based on efficiencies of operations. When cited for violations, these contractors may continue to violate the law due to a shortage of investigators leading to long investigation periods and ability to delay imposition of the penalties due to protections of their legal rights. By the time a case is finally adjudicated, the length of time the contractor is

suspended may be already or almost

completed. If a contractor who does not pay prevailing wages is awarded a contract by underbidding other contractors who base their bids on prevailing wages, then the level playing field is eroded.

These proposed amendments would maintain fair bidding and protection of workers' rights and benefits by strengthening the penalty provisions as stated and by providing sufficient notification of the suspension to the entities involved in the construction project.

Impact on the public: These amendments will maintain the fair bidding process on state and county public works construction projects.

Impact on the department and other agencies: These changes will strengthen enforcement of chapter 104, HRS.
