A BILL FOR AN ACT

RELATING TO YOUTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in the United 2 States, more than one-fourth of our children, over fifteen 3 million children, are left alone and unsupervised after school. 4 Thirty per cent, or nearly four million, of middle school 5 students are left unsupervised until their parents return home 6 from work. The legislature further finds that juvenile violence 7 peaks in the after-school hours on school days and in the 8 evenings on non-school days. Sixty-three per cent of violent 9 crimes committed by juveniles occur on school days, while nearly 10 one-fifth of all juvenile violent crimes occur between the hours 11 of three and seven o'clock in the evening. During fiscal year 12 2013, the police made over three thousand arrests of juveniles 13 in Hawaii between the ages of twelve and fourteen.

14 The legislature finds that according to the department of 15 education's 2011 superintendent's 22nd annual report, Hawaii's 16 dropout rate has reached over sixteen per cent with a graduation

1 rate of only around eighty per cent. Nearly half of the high 2 school drop outs reported that they started high school ill-3 prepared. The legislature further finds that research indicates 4 that each disconnected youth costs the taxpayers nearly \$14,000 5 per year, which can continue and even increase in the future as 6 some disenfranchised youth become part of the juvenile 7 justice/court systems. The stakes of disengagement are high. 8 Once students are disconnected, recruitment, enrollment, and 9 retention into programs require stronger and more persistent 10 outreach, more intensive services, and more long-term 11 participation.

12 The legislature finds that middle/intermediate school years 13 are a pivotal time for our keiki, a time when they can succumb 14 to peer pressure and significantly derail their education and 15 futures. Accordingly, participation in high-quality after-16 school programs can lead to improved attendance, better behavior 17 and better academic performance. Keeping our keiki engaged in 18 positive after-school activities will help to keep them on the 19 path towards graduation and productive futures. Currently, 20 there are approximately thirty-nine thousand middle/intermediate 21 public school students in Hawaii. Approximately half of the 22 fifty-four middle/intermediate schools receive some federal or

1 state funding for after-school programming. However, such 2 funding is inconsistent or unreliable. 3 The legislature finds that in March 2013, the 4 administration, through the lieutenant governor, established the 5 R.E.A.C.H. initiative, which stands for "resources for 6 enrichment, athletics, culture, and health" to develop a 7 standardized framework and funding for after-school programs for 8 public middle/intermediate school students throughout the State. 9 The legislature further finds that the establishment of a state-10 subsidized after-school program for middle/intermediate public 11 school students is important to the future of our keiki and the 12 welfare of our State as a whole.

13 The legislature further finds that the office of youth 14 services, within the department of human services, provides 15 comprehensive front end services and programs for youth to 16 prevent delinquency and reduce the incidence of recidivism. The 17 office is dedicated to creating opportunities for youth to 18 develop competencies that foster resiliency and enable them to 19 achieve a successful transition to young adulthood. The 20 legislature determines that the objectives of the R.E.A.C.H. 21 initiative are wholly aligned with those of the office of youth 22 services.

1 The purpose of this Act is to establish the R.E.A.C.H. 2 program to provide a standardized framework and funding for 3 after-school programs in public middle/intermediate schools. 4 This Act also: 5 (1)Establishes a revolving fund to receive fees and other 6 moneys to supplement the costs of administering and 7 operating the program; 8 (2)Appropriates funds for establishing the R.E.A.C.H. 9 program to provide funding for after-school programs 10 in middle/intermediate public schools; and 11 (3) Establishes one full-time equivalent position to 12 support the program and appropriates funds for that 13 position. 14 SECTION 2. Chapter 352D, Hawaii Revised Statutes, is 15 amended by adding three new sections to be appropriately 16 designated and to read as follows: 17 "§352D-Resources for enrichment, athletics, culture, 18 and health program; established. (a) There is established the 19 resources for enrichment, athletics, culture, and health program 20 within the office. 21 Resources for enrichment, athletics, culture, §352D-22 and health program; powers and duties.

Description:

Establishes the R.E.A.C.H. (Resources for Enrichment, Athletics, Culture, and Health) program in the Office of Youth Services to provide a standardized framework and funding for afterschool programs in public middle/intermediate schools. Establishes a revolving fund to receive fees and other moneys to supplement the costs of administering and operating the program. Establishes one full-time equivalent position to support the program. Appropriates funds.

JUSTIFICATION SHEET

DEPARTMENT: Office of the Lieutenant Governor

TITLE: A BILL FOR AN ACT RELATING TO THE YOUTH.

PURPOSE: The purpose of this bill is to establish the Resources for Enrichment, Athletics, Culture, and Health (R.E.A.C.H.) program to be administered by the Office of Youth Services; establish a revolving fund for the program; establish a new position and appropriate funds for program operations.

MEANS: Establishes new sections within Chapter 352D, HRS.

JUSTIFICATION: Middle/intermediate school years are a pivotal time for our keiki, a time when they can succumb to peer pressure and significantly derail their education and futures. Participation in high-quality afterschool programs can lead to improved attendance, better behavior and better.

> The Office of the Lieutenant Governor established the R.E.A.C.H. initiative in 2013 with the support of funds appropriated by the Legislature that were expended for a pilot program to establish, support or expand afterschool programs in middle/intermediate schools within the State. The mission of R.E.A.C.H. is to provide positive programs to keep middle/intermediate school youth engaged and on the path towards graduation.

The Office of Youth Services provides comprehensive front end services and programs for youth to prevent delinquency and reduce the incidence of recidivism.

The general fund appropriation included in this measure has been made in accordance with the statutorily defined appropriation ceiling for the Executive Branch pursuant to



section 37-92, HRS. With a decrease of general fund appropriations of -\$53,151,500 for fiscal year 2013-2014 and an increase of general fund appropriations of \$470,361,342 for fiscal year 2014-2015 proposed in the Executive Supplemental Budget, the appropriation ceiling for the Executive Branch will be exceeded by \$304,982,041 or 4.7 percent in fiscal year 2014-2015. Funding requested in this measure for the R.E.A.C.H. initiative will result in the appropriation ceiling for the Executive branch to now be exceeded in fiscal year 2014-2015 by an additional \$3,100,000 or .0478 percent. This current declaration takes into account additional general fund appropriations authorized for fiscal year 2014-2015 in the Executive Supplemental . Budget and this measure only, and does not include other general fund appropriations for fiscal year 2014-2015 that may be authorized for the Executive Branch in other legislation submitted to the Legislature during the regular session of 2014.

Impact on the public: The proposed bill will establish a program and funding to provide for after-school programs in middle/intermediate schools that current to not receive federal or UPLINKS funding. Participation in these after-school programs can help to keep students engaged and excited about learning and keep them on the path towards graduation, thereby helping to reduce dropout rates and future draws on public resources.

Impact on the department and other agencies: The Office of Youth services will undertake a new program that is in line with its current mission to provide support for our youth.
