A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the order of the		
2	placement of candidates' names on a ballot can influence a		
3	voter's decision. It has been documented that candidates who		
4	are listed at the top of the ballot are at an advantage and		
5	receive, on average, two per cent more votes than if they had		
6	been listed later on the ballot.		
7	Accordingly, the purpose of this Act is to improve the		
8	elections process by arranging candidates' names on a ballot in		
9	alphabetical order commencing with a randomly-drawn letter.		
10	SECTION 2. Section 11-115, Hawaii Revised Statutes, is		
11	amended to read as follows:		
12	"§11-115 Arrangement of names on the ballot. (a) The		
13	names of the candidates shall be placed upon the ballot for		
14	their respective offices in alphabetical order [except:];		
15	<pre>provided that:</pre>		
16	(1) Prior to each election cycle, the chief election		
17	officer shall select a letter of the alphabet by lot;

1	(2)	rot primary, general, and special elections during
2		each election cycle, candidates whose last names begin

4		shall appear first on the ballot in alphabetical order

7		with the letter that follows the letter selected
8		pursuant to subsection (1), and continuing to the
9		letter Z, then returning to the letter A.
10	<u>(b)</u>	In addition to the requirements of subsection (a),

12	(1)	As provided in section 11-118;
13	(2)	[For] Subject to the limitations of the voting system
14		in use; and
15	(3)	[For] In the case of the candidates for vice president
16		and lieutenant governor in the general election
17		[whose], the names of those candidates shall be placed
18		immediately below the name of the candidate for
19		president or governor of the same political party.

- 1 the following format shall be used: A horizontal line shall be
- 2 ruled between each candidate's name and the next name, except
- 3 between the names of presidential and vice presidential
- 4 candidates and candidates for governor and lieutenant governor
- 5 of the same political party in the general election. In such
- 6 case the horizontal line shall follow the name of the candidates
- 7 for vice president and lieutenant governor of the same political
- 8 party, thereby grouping the candidates for president and vice
- 9 president and governor and lieutenant governor of the same
- 10 political party within the same pair of horizontal lines.
- 11 [(c)] (d) Immediately to the left of (before) or to the
- 12 right of (after) the candidate name or names, according to the
- 13 requirements of the voting system, two vertical lines shall be
- 14 ruled, so that in conjunction with the horizontal lines, a box
- 15 shall be formed to the left of or to the right of the name and
- 16 its equivalent, if any.
- 17 [\(\frac{(d)}{d}\)] (e) In case of the candidates for president and vice
- 18 president and governor and lieutenant governor of the same
- 19 political party, only one box shall be formed opposite their set
- 20 of names. The boxes shall be of sufficient size to give ample
- 21 room in which to designate the choice of the voter in the manner
- 22 prescribed for the voting system in use. All of the names upon

- 1 a ballot shall be placed at a uniform distance from the left
- 2 edge and close thereto, and shall be of uniform size and print
- 3 subject to section 11-119."
- 4 SECTION 3. The chief election officer shall establish
- 5 procedures to implement the purpose of this Act, and provide
- 6 appropriate explanation to voters regarding the arrangement of
- 7 candidates' names on the ballot.
- 8 SECTION 4. Statutory material to be repealed is bracketed
- 9 and stricken. New statutory material is underscored.
- 10 SECTION 5. This Act shall take effect upon its approval;
- 11 provided that if it is not enacted by June 3, 2014, it shall
- 12 take effect on November 5, 2014.
