A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii health insurance exchange, known as 2 the Hawaii health connector, was established in 2011 to ensure 3 the State's compliance with the federal Patient Protection and 4 Affordable Care Act of 2010. The federal law allows for the 5 establishment of state health insurance exchanges through which 6 qualified individuals and small employers can purchase private 7 health insurance from an array of affordable, comprehensive health insurance plans. Act 205, Session Laws of Hawaii 2011, 8 9 established the Hawaii health connector as a private nonprofit 10 organization independent from state government rather than a 11 state agency.

12 Federal law creates a framework for the state health 13 insurance exchanges. The Patient Protection and Affordable Care 14 Act of 2010 sets minimum structural and operational standards 15 for states in establishing their health insurance exchanges. 16 States have broad discretion in establishing the structure and 17 governance of their exchanges. The federal law relies on the

states to make critical choices in the structure and operations
 of their respective exchanges.

3 The legislature finds that evolving federal health care
4 regulations and the need for greater transparency and oversight
5 over Hawaii's health insurance exchange necessitate that the
6 State revise the structure of the Hawaii health connector.

7 The purpose of this Act is to provide greater transparency8 and oversight over Hawaii's health insurance exchange by:

9 (1) Creating a consumer, patient, business, and health
10 care advisory group and an intergovernmental agency
11 advisory group to provide input and recommendations to
12 the board of directors of the Hawaii health connector;
13 (2) Establishing the Hawaii health connector as a state
14 entity; and

15 (3) Making changes to the composition of the board of
16 directors of the Hawaii health connector.

SECTION 2. Chapter 435H, Hawaii Revised Statutes, is
amended by adding two new sections to be appropriately
designated and to read as follows:

 20 "<u>§435H-</u> <u>Consumer, patient, business, and health care</u>
 21 <u>advisory group.</u> The board of directors of the Hawaii health

1	health care advisory group to provide input and recommendations
2	to the board. The advisory group shall reflect geographic
3	diversity and diversity of interests. Members shall include
4	individuals with education, training, or professional experience
5	in the fields of consumer advocacy, patient advocacy, public
6	health, health care provision, economics, health insurance,
7	financial management, risk management, and small business.
8	Members of the advisory group shall serve in an advisory
9	capacity only and shall not be considered state employees for
10	any purpose. Members shall not be compensated but shall be
11_	reimbursed for necessary expenses incurred in the performance of
12	their duties.
13	§435H- Intergovernmental agency advisory group. There
14	is established an intergovernmental agency advisory group that
15	shall serve in an advisory capacity to provide input and
16	recommendations to the board. The advisory group shall consist
17	of the following members:
18	(1) The director of commerce and consumer affairs;
19	(2) The director of health; and
20	(3) The director of labor and industrial relations.
21	The governor shall designate one member to convene and serve as

22 the chair of the advisory group."



1	SECTION 3. Section 435H-2, Hawaii Revised Statutes, is
2	amended by amending subsection (a) to read as follows:
3	"(a) There is established within the department of
4	commerce and consumer affairs the Hawaii health insurance
5	exchange to be known as the Hawaii health connector. The
6	connector shall [not] be a public body corporate and politic and
7	an instrumentality and agency of the State [and shall not be
8	subject to laws or rules regulating rulemaking, public
9 ·	employment, or public procurement. The connector shall be a
10	Hawaii nonprofit corporation organized and governed pursuant to
11	chapter 414D, the Hawaii nonprofit corporations act.] except
12	that the debts and liabilities of the connector shall not
13	constitute the debts and liabilities of the State."
14	SECTION 4. Section 435H-4, Hawaii Revised Statutes, is
15	amended to read as follows:
16	"§435H-4 Board of directors; composition; operation. (a)
17	The Hawaii health connector shall be [a nonprofit entity]
18	governed by a board of directors that shall comprise [fifteen]
19	nine voting members as follows:
20	(1) The insurance commissioner;
21	(2) The director of human services;
22	(3) The healthcare transformation coordinator;

20	providers]. Each person appointed to the board shall have
21	education	, training, or professional experience in at least one
22	of the fo	llowing areas:

5	(c) Board members shall serve staggered terms [and the
6	interim board-shall recommend an appropriate schedule for
7	staggered terms;] of four years each, provided that [this] the
8	terms of the initial appointments of members pursuant to Act ,
9	Session Laws of Hawaii 2014, shall be as follows:
10	(1) One member appointed by each appointing authority
11	shall be appointed for two years; and
12	(2) One member appointed by each appointing authority
13	shall be appointed for four years.
14	This subsection shall not apply to ex officio members, who shall
15	serve during their entire term of office.
16	(d) Any vacancy on the board shall be filled for the
17	remainder of the unexpired term in the same manner as the
18	original appointment as specified in subsection (a). Any member
19	whose term has expired and who is not disqualified from
20	membership may continue in office until a successor is
21	appointed.

1 [(d)] (e) The board shall adopt policies prohibiting 2 conflicts of interest and procedures for recusal of a member in 3 the case of an actual or potential conflict of interest, 4 including policies prohibiting a member from taking part in 5 official action on any matter in which the member had any 6 financial involvement or interest prior to the commencement of 7 service on the board. Members of the board may retain private 8 counsel for matters relating to service on the board according 9 to rules recommended by the board.

10 [-(e)-] (f) The board shall manage the budget of the
11 connector according to generally accepted accounting principles
12 and a plan for financial organization adopted by the legislature
13 based on recommendations of the interim board.

14 [(f)] (g) The board shall maintain transparency of board 15 actions, including public disclosure and posting of board 16 minutes on the connector's website according to provisions 17 adopted by the legislature based on recommendations of the 18 interim board."

19 SECTION 5. The director of commerce and consumer affairs 20 shall work with the board of directors of the Hawaii health 21 connector as constituted pursuant to Act 205, Session Laws of 22 Hawaii 2011, in order to effectuate a seamless transition of

duties, functions, and records to the amended governance
 structure of the Hawaii health connector as required by this
 Act. Transition procedures shall ensure that no interruption
 occurs in the provision of health coverage or health care
 services to any individual or business served by or eligible for
 service through the Hawaii health connector.


7 Planning and coordination for the transition of the duties,
8 functions, and records of the Hawaii health connector as
9 constituted pursuant to Act 205, Session Laws of Hawaii 2011, to
10 the amended governance structure of the Hawaii health connector
11 as provided by this Act shall be completed in a timely manner in
12 order for the amended governance structure established by this
13 Act to take effect on January 1, 2016.

SECTION 6. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that were begun before its effective date.

17 SECTION 7. Statutory material to be repealed is bracketed18 and stricken. New statutory material is underscored.



SECTION 8. This Act shall take effect upon its approval;
 provided that that sections 2, 3, and 4 shall take effect on
 January 1, 2016.
