## A BILL FOR AN ACT

RELATING TO KAWAINUI.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Kawainui, encompassing approximately eight
- 2 hundred thirty acres of land in Kailua, Oahu, is the State's
- 3 largest remaining wetland and an ecological and cultural
- 4 treasure of statewide interest. It has been identified by the
- 5 United States Fish and Wildlife Service as a primary habitat for
- 6 endemic and endangered Native Hawaiian birds such as the 'alae
- 7 ke'oke'o, 'alae 'ula, ae'o, and koloa maoli. In 2005, the Ramsar
- 8 Convention on Wetlands designated the Kawainui-Hamakua complex
- 9 as a wetland of international importance in part due to the
- 10 wetlands relationship to surrounding cultural sites.
- 11 Act 314, Session Laws of Hawaii 1990 (Act 314), directed
- 12 the transfer to the State of that certain parcel owned by the
- 13 city and county of Honolulu and bearing tax map key number
- 14 4-2-16:1, which encompasses the bulk of Kawainui. The parties
- 15 were unsuccessful in completing the transfer.
- 16 Since the passage of Act 314, the health of the Kawainui
- 17 area has declined significantly despite the advocacy and

- 1 restoration efforts of community groups such as 'Ahahui Malama I
- 2 Ka Lokahi, the Kailua Hawaiian Civic Club, Kailua Historical
- 3 Society, and the Windward Ahupua'a Alliance.
- 4 Act 235, Session Laws of Hawaii 2007, again addressed the
- 5 transfer of this parcel to the State. In October 2008, the city
- 6 and county of Honolulu transferred ownership of the parcel to
- 7 the State, and the department of land and natural resources was
- 8 given jurisdiction over the complex.
- 9 In 2011, the department of land and natural resources began
- 10 to hold public meetings to discuss a draft of the revised master
- 11 plan for Kawainui. An informal community meeting was held in
- 12 November 2013, and more than two hundred fifty people attended.
- 13 Ho'olaulima Īa Kawainui, a network of conservation, native
- 14 Hawaiian, education, and community organizations, has been
- 15 assisting with planning the future of Kawainui since 2004.
- 16 Members meet on a regular basis to share information, take
- 17 action on issues affecting Kawainui, and participate in
- 18 community events and forums to help educate the community about
- 19 Kawainui. Ho'olaulima Īa Kawainui has been an integral part of
- 20 bringing the community together to focus on the restoration and
- 21 stewardship of Kawainui.

1	The purpose of this Act is to ensure continued community		
2	participation in the preservation and protection of Kawainui		
3	after the completion of the master plan update process by		
4	establishing the Kawainui advisory council.		
5	SECTION 2. Chapter 171, Hawaii Revised Statutes, is		
6	amended by adding a new section to be appropriately designated		
7	and to read as follows:		
8	"§171- Kawainui advisory council. (a) There is		
9	established a Kawainui advisory council, to be placed within the		
10	department of land and natural resources for administrative		
11	purposes only. Notwithstanding any law to the contrary, the		
12	advisory council shall consist of nine voting members and five		
13	nonvoting members as follows:		
14	(1) Nine voting members, appointed by the governor		
15	pursuant to section 26-34, representing Kawainui		
16	cultural, educational, environmental, landowner, and		
17	community stakeholder groups; provided that in		
18	appointing members pursuant to this section, the		
19	governor shall ensure broad representation from		
20	cultural, educational, environmental, landowner, and		
21	community groups; provided further that members		
22	appointed pursuant to this section shall serve a term		

1		of two years and no more than three consecutive terms;
2		<u>and</u>
3.	(2)	Five nonvoting members representing the United States
4		Army Corps of Engineers, United States Fish and
5		Wildlife Service, department of land and natural
6	·	resources forestry and wildlife division, department
7		of land and natural resources state parks division,
8		and city and county of Honolulu.
9	<u>(b)</u>	Each voting member shall be appointed by the governor
10	no later	than December 31, 2014. The members of the advisory
11	council s	hall not receive compensation for their service but
12	shall be	reimbursed for expenses, including travel expenses,
13	incurred	in their duties relating to the advisory council.
14	<u>(c)</u>	A chairperson shall be elected annually by the council
15	from amon	g the council's voting members; provided that:
16	(1)	Only a nongovernmental member shall be elected as
17	•	chairperson; and
18	(2)	No member may serve as chairperson for more than one
19		term.
20	<u>(d)</u>	Five voting members shall constitute a quorum to do
21	business,	and any action taken by the advisory council shall be
22	validated	by a simple majority of the quorum.

1	<u>(e)</u>	The Rawainur advisory Council Shair:	
2	(1)	Facilitate implementation of the updated master plan	
3		by providing advisory input to the department of land	
4		and natural resources;	
5	(2)	Enhance community education and cultural awareness of	
6		Kawainui; and	
7	<u>(3)</u>	Participate in the protection and preservation of	
<b>8</b> .		Kawainui's natural and cultural resources.	
9	<u>(f)</u>	The Kawainui advisory council shall submit a report to	
10	the legislature no later than twenty days prior to the convening		
11	of each regular session beginning with the regular session of		
12	2016; provided that the report to the legislature prior to the		
13	convening of the regular session of 2023 shall include a		
14	recommendation as to whether or not the advisory council should		
15	be dissolved on June 30, 2024."		
16	SECTION 3. Until the Kawainui advisory council is		
17	established pursuant to section 2 of this Act, the department of		
18	land and natural resources shall consult with Hoʻolaulima Īa		
19	Kawainui	on all issues relating to Kawainui. The department of	
20	land and	natural resources, in collaboration with Hoʻolaulima Īa	
21	Kawainui,	shall submit a report of its findings to the

- 1 legislature no later than twenty days prior to the convening of
- 2 the regular session of 2015.
- 3 SECTION 4. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$50,000 or so much
- 5 thereof as may be necessary for fiscal year 2014-2015 to support
- 6 the work of the Kawainui advisory council, including the
- 7 implementation of the Kawainui master plan, and for one full
- 8 time equivalent (1.0 FTE) executive secretary within the
- 9 department of land and natural resources to support the work of
- 10 the Kawainui advisory council.
- 11 The sum appropriated shall be expended by the department of
- 12 land and natural resources for the purposes of this Act.
- 13 SECTION 5. New statutory material is underscored.
- 14 SECTION 6. This Act shall take effect on July 1, 2020;
- 15 provided that:
- 16 (1) Section 4 shall take effect on July 1, 2014; and
- 17 (2) This Act shall be repealed on June 30, 2024.
