BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 6E, Hawaii Revised Statutes, is amended 2 by adding a new section to part IV to be appropriately 3 designated and to read as follows: 4 "§6E- Naming commission; state buildings, parks, and facilities; establishment; appointment; composition; duties. 5 (a) There is established within the department an advisory 6 commission to propose names for state buildings, parks, and 7 facilities. The commission shall consist of nine members to be 8 appointed by the governor in the manner provided by section 26-9 10 34; provided that: Three members shall be appointed from a list of not 11 (1)12 less than nine nominees submitted by the speaker of the house of representatives; 13 <u>(</u>2) Three members shall be appointed from a list of not 14 less than nine nominees submitted by the president of 15 16 the senate;

14	in discharge of their duties.	
15	(d)	The department shall provide staff as necessary,
16	including	clerical support staff, to assist the commission in
17	its duties.	
18	<u>(e)</u>	The commission shall be responsible for proposing
19	names or a change of name for any state building, park, or other	
20	state facility.	
21	(f)	The commission shall submit any proposals to the
22	governor	for the governor's consideration.
