A BILL FOR AN ACT

RELATING TO HAWAII 3R'S.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Hawaii 3R's, a Hawaii nonprofit organization, 2 brings private financing and human resources together to tackle 3 the repair and maintenance backlog in Hawaii's public schools. 4 The Legislature finds that for more than a decade, Hawaii 3R's 5 provided a valuable service of bringing much needed improvements 6 to the public schools. Section 235-102.5(b), Hawaii Revised 7 Statutes, enables taxpayers to elect to make donations toward 8 the school-level minor repairs and maintenance special fund by 9 checking off a box on tax returns. When passed, the section was 10 intended to facilitate funding for the repair and maintenance of 11 Hawaii's public schools.

By amending the title to read: "§302A-1502.4 Hawaii 3R's school [repair and maintenance] 6 7 improvement fund." 8 2. By amending subsections (a) through (c) to read: "(a) There is established the Hawaii 3R's school [repair 9 and maintenance] improvement fund (hereinafter, "fund") as a 10 11 separate restricted fund of Hawaii 3R's, a Hawaii nonprofit organization. Moneys received from the State, county, or 12 federal government, private contributions of cash or other 13 property, and the income and capital gains earned by the fund 14 shall constitute its assets. 15 (b) Hawaii 3R's shall expend moneys from the fund in the 16 form of either grants to organizations or contracts with private 17 vendors for the [repair and maintenance] improvement of public 18 schools and students in Hawaii in accordance with this section. 19 20 The fund may receive contributions, grants, (C) endowments, or gifts in cash or otherwise from all sources, 21 22 including corporations or other businesses, foundations, 2014-0735 HB SMA.doc

1 government, individuals, and other interested parties. The fund 2 shall also receive moneys transferred to it from the school-3 level minor repairs and maintenance special fund established under section 302A-1504.5. The legislature intends that public 4 5 and private sectors review and investigate all potential funding sources. The State may appropriate moneys to the fund; provided 6 7 that any appropriations made by the State are not intended to 8 supplant the funding of any existing [school level minor repairs 9 and maintenance] programs."

11 "(e) The fund shall not be placed in the state treasury, 12 and [the State shall not administer the fund, nor shall] the 13 State shall not be liable for the operation or solvency of the 14 fund or Hawaii 3R's."

15 SECTION 3. Section 302A-1504.5, Hawaii Revised Statutes,
16 is amended by amending subsection (a) to read as follows:

17 "(a) There is established within the state treasury a 18 special fund to be known as the school-level minor repairs and 19 maintenance special fund, into which shall be deposited all 20 moneys collected pursuant to section 235-102.5(b), and any other 21 moneys received by the department in the form of grants and 22 donations for school-level <u>improvements and</u> minor repairs and

The special fund shall be administered by the 1 2 department and used to fund school-level minor repairs and The department shall transfer moneys collected 3 maintenance. 4 in the form of grants and donations for school-level 5 improvements and minor repairs and maintenance to the Hawaii 6 3R's school improvement fund established pursuant to section 7 302A-1502.4." 8 SECTION 4. Statutory material to be repealed is bracketed 9 10 and stricken. New statutory material is underscored. This Act shall take effect upon its approval. SECTION 5. 11 12
