### A BILL FOR AN ACT

RELATING TO HAWAII 3R'S.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Hawaii 3R's, a Hawaii nonprofit organization, 2 brings private financing and human resources together to tackle 3 the repair and maintenance backlog in Hawaii's public schools. 4 The Legislature finds that for more than a decade, Hawaii 3R's 5 provided a valuable service of bringing much needed improvements 6 to the public schools. Section 235-102.5(b), Hawaii Revised 7 Statutes, enables taxpayers to elect to make donations toward 8 the school-level minor repairs and maintenance special fund by 9 checking off a box on tax returns. When passed, the section was 10 intended to facilitate funding for the repair and maintenance of 11 Hawaii's public schools.

The fund 2 shall also receive moneys transferred to it from the school-3 level minor repairs and maintenance special fund established under section 302A-1504.5. The legislature intends that public 4 5 and private sectors review and investigate all potential funding sources. The State may appropriate moneys to the fund; provided 6 7 that any appropriations made by the State are not intended to 8 supplant the funding of any existing [school level minor repairs 9 and maintenance] programs."

11 "(e) The fund shall not be placed in the state treasury, 12 and [the State shall not administer the fund, nor shall] the 13 State shall not be liable for the operation or solvency of the 14 fund or Hawaii 3R's."

15 SECTION 3. Section 302A-1504.5, Hawaii Revised Statutes,
16 is amended by amending subsection (a) to read as follows:

17 "(a) There is established within the state treasury a 18 special fund to be known as the school-level minor repairs and 19 maintenance special fund, into which shall be deposited all 20 moneys collected pursuant to section 235-102.5(b), and any other 21 moneys received by the department in the form of grants and 22 donations for school-level <u>improvements and</u> minor repairs and

The special fund shall be administered by the 1 2 department and used to fund school-level minor repairs and The department shall transfer moneys collected 3 maintenance. 4 in the form of grants and donations for school-level 5 improvements and minor repairs and maintenance to the Hawaii 6 3R's school improvement fund established pursuant to section 7 302A-1502.4." 8 SECTION 4. Statutory material to be repealed is bracketed 9 10 and stricken. New statutory material is underscored. This Act shall take effect upon its approval. SECTION 5. 11 12
