A BILL FOR AN ACT

RELATING TO ELECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 11, Hawaii Revised Statutes, is amended
2	by adding a new section to part II to be appropriately
3	designated and to read as follows:
4	"§11- Registration on election day. (a)
5	Notwithstanding the closing of the register pursuant to section
6	11-24, an individual who is eligible to vote but has not
7	previously registered may register on election day by appearing
8	in person at a polling place for the county in which the
9	individual maintains residence.
10	(b) The county clerk may designate a registration clerk,
11	who may be an election official, at any of the polling places in
12	the county on the day of the election. These registration
13	clerks shall process registration applications for individuals
14	not registered to vote and shall require such individuals to
15	submit:
16	(1) A signed affidavit in accordance with section 11-15

9		<u>(A)</u>	A valid driver's license, state identification

11			individual's current address;
12		<u>(B)</u>	A document that contains the name and address of

14			paycheck, government check, residential lease,
15		;	current utility bill, current telephone bill, or
16			any other government document or card;
17		<u>(C)</u>	Any other document that is approved by the office
18			of elections as sufficient proof of residence;
19		<u>(D)</u>	A student identification card, fee statement, or
20			registration card from a post-secondary
21			educational institution in the State, or other
22			document from a post-secondary educational

		institution that verifies the student's current		
2		address;		
3	<u>(E)</u>	A tribal identification card showing the		
4		<pre>individual's current address;</pre>		
5	<u>(F)</u>	Verification by an administrator, or the		
6		administrator's designee, of a nursing home or		
7		similar facility where the individual resides; or		
8	<u>(G)</u>	A self-subscribing affidavit of residency signed		
9		under oath and under penalty of perjury, pursuant		
10		to section 11-15(b).		
11	(c) Regi	stration may be challenged in accordance with		
12	section 11-25(b) and is subject to a final decision by the		
13	county clerk o	r the registration clerk assigned to the polling		
14	place.			
15	(d) Elec	tion day registration pursuant to this chapter may		
16	also be used b	y an individual who is eligible to vote but whose		
17	name cannot be	found on the precinct list for the polling place		
18	corresponding to the individual's address.			
19	(e) The	clerk of each county shall add individuals who		
20	properly regis	ter on election day to the respective general		
21	register. Wit	hin thirty days of registration at the polling		
22	place, the cou	nty clerk shall mail to the individual a notice
