## A BILL FOR AN ACT

RELATING TO GAMBLING OFFENSES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's gambling 2 laws are being circumvented by a recent trend in which 3 participants make purchases of goods or services that entitle 4 the purchaser to participate in gaming activities on machines that offer payouts and otherwise constitute gambling. The 5 participant earns more credits or plays each time money is spent 6 7 or deposited into the machine. Establishments that promote these activities claim that the activities do not constitute 8 9 gambling. The legislature disagrees. However, law enforcement 10 has found that participants, and even employees of the establishments that provide the machines and activities, are 11 unaware of, or completely disregard, the purchased goods or 12 13 services and proceed directly to the gaming activity. Hence, it 14 is clear that the intent of these establishments and machines is 15 to promote gambling.

16 The purpose of this Act is to amend chapter 712, Hawaii
17 Revised Statutes, to clarify the gambling laws to provide that

gambling activities offered incident to the purchase of goods or
 services constitute gambling.

3 SECTION 2. Section 712-1220, Hawaii Revised Statutes, is
4 amended by amending the definitions of "gambling", "gambling
5 device", and "something of value" to read:

6 "(4) "Gambling". A person engages in gambling if he 7 stakes or risks something of value upon the outcome of a contest 8 of chance or a future contingent event not under his control or 9 influence, upon an agreement or understanding that he or someone 10 else will receive something of value in the event of a certain 11 outcome. Gambling:

12(a)Includes the use of any gambling device that is13offered incident to the purchase of other goods or

14 services, at no additional charge;

But does not include bona fide business transactions 15 (b) valid under the law of contracts, including but not 16 17 limited to contracts for the purchase or sale at a future date of securities or commodities, and 18 agreements to compensate for loss caused by the 19 happening of chance, including but not limited to 20 contracts of indemnity or guaranty and life, health, 21 22 or accident insurance.

contemplating transfer of money or property or of any interest
 therein, or involving extension of a service or entertainment."

3 SECTION 3. This Act does not affect rights and duties that 4 matured, penalties that were incurred, and proceedings that were 5 begun before its effective date.

6 SECTION 4. Statutory material to be repealed is bracketed7 and stricken. New statutory material is underscored.

8 SECTION 5. This Act shall take effect upon its approval.
