#### A BILL FOR AN ACT

RELATING TO NOISE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 663, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§663-</u> Noise; private nuisance; relief. (a) A person
5	who alleges the existence of a private nuisance due to excessive
6	noise may bring a civil action for appropriate injunctive
7	relief, actual damages, or both. A civil action for actual
8	damages must be brought within two years after the occurrence of
9	the alleged private nuisance.
10	(b) An action commenced pursuant to subsection (a) may be
11	brought in the circuit court for the circuit where the alleged
12	violation occurred, where the complainant resides, or where the
13	person against whom the civil complaint is filed resides or has
14	a principal place of business.
15	(c) For purposes of this section:
16	"Damages" means damages for injury or loss caused by
17	excessive noise or vibration.



1	"Excessive noise" means any noise that exceeds those noise
2	levels permissible under applicable state law or rule or county
3	ordinance.
4	"Nuisance" means any interference with reasonable use and
5	enjoyment of property and includes all claims that meet the
6	requirements of this definition regardless of whether a
7	complainant designates the claims as brought in nuisance,
8	negligence, trespass, or any other claim under law or equity.
9	(d) Nothing in this section shall in any way restrict or
10	impede the authority of the State or the counties to protect the
11	public health, safety, and welfare."
12	SECTION 2. Section 342F-12, Hawaii Revised Statutes, is
13	amended to read as follows:
14	"\$342F-12 Injunctive and other relief. (a) The director
15	may institute a civil action in any court of competent
16	jurisdiction for injunctive and other relief to prevent any
17	violation of this chapter, any rule adopted pursuant to this
18	chapter, or any condition of a permit or variance issued
19	pursuant to this chapter, without the necessity of a prior
20	revocation of the permit or variance, to impose and collect

1	obtain other relief. The court shall have power to grant relief
2	in accordance with the Hawaii rules of civil procedure.
3	(b) Nothing in this chapter shall be construed to preclude
4	a private action pursuant to section 663"
5	SECTION 3. This Act does not affect rights and duties that
6	matured, penalties that were incurred, and proceedings that were
7	begun before its effective date.
8	SECTION 4. New statutory material is underscored.
9	SECTION 5. This Act shall take effect upon its approval.
