5	SECT	ION 2. (a) The department of land and natural	
6	resources	shall conduct a flood study for Waipio valley on the	
7	island of	Hawaii. The flood study shall include at least the	
8	following	:	
9	(1)	Specific recommendations for the control of storm	
10		damage throughout the study area to reduce repetitive	
11		flooding to residences and businesses in the area;	
12	(2)	A cost-benefit analysis of the recommendations	
13		proposed;	
14	(3)	Identification and evaluation of the desired,	
15		intended, and possibly unintended effects of the	
16		recommendations;	
17	(4)	A timetable for the implementation of the	
18		recommendations; and	
19	(5)	Any other issues deemed necessary or relevant by the	
20		chairperson of the board of land and natural

1 The department of land and natural resources shall (b) 2 submit a written report of its findings and recommendations, 3 including any proposed legislation, to the legislature no later 4 than twenty days prior to the convening of the regular session 5 of 2014. 6 SECTION 3. There is appropriated out of the general 7 revenues of the State of Hawaii the sum of \$ or so much 8 thereof as may be necessary for fiscal year 2013-2014 for a 9 flood study for Waipio valley on the island of Hawaii. 10 The sum appropriated shall be expended by the department of 11 land and natural resources for the purposes of this Act. 12 PART III 13 SECTION 4.
