19	Waipio Valley Flood Damage Reduction and Stream Stabilization		
20	Preliminary Investigation report prepared by AECOM. The report		
21	recommended mitigation measures at the Kawashima Waterhead and		

- 1 the Linda Beech Crossing to stabilize the Wailoa stream channel
- 2 and protection against erosion.
- 3 The purpose of this part is to appropriate moneys to fund
- 4 flood damage and stream erosion mitigation measures in Waipio
- 5 valley.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so much
- 8 thereof as may be necessary for fiscal year 2013-2014 for the
- 9 design and construction of flood damage reduction and stream
- 10 stabilization in Waipio valley on the island of Hawaii.
- 11 The sum appropriated shall be expended by the department of
- 12 land and natural resources for the purposes of this part.
