A BILL FOR AN ACT

RELATING TO ANIMAL CRUELTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is important to
- 2 protect pet animals from cruel treatment and prevent pet animals
- 3 from enduring unnecessary or prolonged suffering. Steel-jawed
- 4 leg-hold traps were originally designed to capture fur-bearing
- 5 animals such as bears, foxes, beavers, and other animals that
- 6 are not present in Hawaii. Snares and foot- or leg-hold traps
- 7 were designated to capture other non-domesticated animals.
- 8 Unfortunately, domesticated pet animals are frequent
- 9 victims of snares and may also become victims of steel-jawed
- 10 leg-hold, conibear, or foot- or leg-hold traps. Cases have been
- 11 reported of dogs and cats found dead or severely injured after
- 12 being caught in these devices or chewing off their own limbs in
- 13 an attempt to escape these devices.
- 14 The legislature further finds that existing laws and
- 15 administrative rules do not prohibit or regulate the use of
- 16 steel-jawed leg-hold, conibear, foot- or leg-hold traps or
- 17 snares, all of which can be easily purchased on the Internet.

1	The	purpose of this Act, therefore, is to:
2	(1)	Establish a reporting requirement for any dog or cat
3		captured or killed in any steel-jawed leg-hold trap,
4		snare, conibear trap, or foot- or leg-hold trap;
5	(2)	Establish an animal cruelty offense for the use of
6		snares, conibear traps, and foot- or leg-hold traps in
7		residential areas and the use of steel-jawed leg-hold
8		traps;
9	(3)	Provide exemptions from the offense for certain
10		activities carried out by state and federal agencies;
11		and
12	(4)	Establish the offense as a misdemeanor.
13	SECTION 2. Chapter 143, Hawaii Revised Statutes, is	
14	amended by adding a new section to be appropriately designated	
15	and to read as follows:	
16	" <u>§14</u>	3- Reporting of dog or cat captured or killed in
17	snare or	trap. Any dog or cat captured or killed in any steel-
18	jawed leg	-hold trap, snare, conibear trap, or foot- or leg-hold
19	trap, as	those terms are defined in section 711- , in an area
20	zoned as residential shall be immediately checked for	
21	<u>identifi</u> c	ation and reported to a county animal control officer,

        (2) Subsection (1) shall not apply to employees of state

    or federal agencies, or persons acting as a designated

    protection of species listed as threatened or endangered

    species, or other wildlife species protected by law, or for the

- 1 (3) As used in this section:
- 2 "Conibear trap" means a contrivance consisting of metal or
- 3 steel designed to kill by crushing the body or severing the
- 4 spinal cord of any animal.
- 5 "Foot- or leg-hold trap" means a contrivance consisting of
- 6 metal or steel that is off-set, padded or laminated, and is
- 7 designed to capture and hold any animal by foot and limb.
- 8 "Snare" means a contrivance consisting of a noose,
- 9 regardless of material, designed to capture, trap, or kill any
- 10 animal or hold any animal by foot, limb, or neck.
- "Steel-jawed leg-hold trap" means a spring-powered
- 12 contrivance that captures or holds the limb of an animal by
- 13 exerting a lateral force with fix-mounted jaws.
- 14 (4) Cruelty to animals by trapping is a misdemeanor."
- 15 SECTION 4. This Act does not affect rights and duties that
- 16 matured, penalties that were incurred, and proceedings that were
- 17 begun before its effective date.
- 18 SECTION 5. New statutory material is underscored.
- 19 SECTION 6. This Act shall take effect upon its approval.

Animal Cruelty; Trapping

Description:

Requires dogs or cats that are captured or killed in a snare or trap to be reported to a county animal control officer. Establishes the offense of cruelty to animals by trapping as a misdemeanor. (HB493 HD1)
