# A BILL FOR AN ACT

RELATING TO URBAN ART.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Defined in the Hawaii Revised Statutes as "any SECTION 1. 2 unauthorized drawing, inscription, figure, or mark of any type 3 intentionally created by paint, ink, chalk, dye, or similar 4 substances," graffiti is a pervasive problem in many communities 5 throughout the State, causing visual blight, resulting in 6 unsightly scenery, and negatively impacting property values. 7 The legislature finds that the negative impacts of graffiti make 8 it an issue of great concern, and to date, the problem persists 9 despite community efforts to combat it. **10** The legislature further finds that while these negative 11 effects cannot be ignored, graffiti is also recognized as a 12 legitimate artistic genre. As urban art, the graffiti style has 13 historically been used as social and political commentary and 14 numerous publications have treated the subject as such. 15 Although there are different theories regarding the purpose and 16 effectiveness of urban art projects as a deterrent to graffiti, 17 a popular theory posits that authorized outlets for urban art
- throughout a community will mitigate instances of graffiti.

The legislature further finds that providing legitimate, 1 state-owned venues for urban art will enrich the State's 2 communities in many ways, including reducing graffiti by 3 expanding opportunities for appropriate creative social 4 5 expression. The purpose of this Act is to create a pilot program for 6 7 the creation of urban art under the direction of the state 8 foundation on culture and the arts. 9 SECTION 2. (a) There is established a pilot program under **10** the direction of the state foundation on culture and the arts 11 for the creation of urban art on state-owned property. The state foundation on culture and the arts shall, in 12 (b) 13 consultation with the department of accounting and general 14 services, the department of transportation, the department of 15 land and natural resources, the state historic preservation 16 division of the department of land and natural resources, and **17** any other stakeholders deemed appropriate by the state 18 foundation on culture and the arts, establish procedures for the 19 pilot program, including procedures that address the following: 20 (1) The selection of participating individuals; 21 Site selection and designation of specific areas for (2)

urban art on state-owned property;

- (c) The state foundation on culture and the arts shall consult with the historic preservation division of the department of land and natural resources, Historic Hawaii

- of urban art under the pilot program to ensure that the art does not negatively impact historic property. The review of an urban
- 17 art proposal shall proceed in accordance with section 6E-8,
- 18 Hawaii Revised Statutes. Any urban art proposal for which the
- 19 department of land and natural resources provides written non-
- 20 concurrence, pursuant to section 6E-8(a), Hawaii Revised
- 21 Statutes, shall not be permitted.

- 1 "Urban art" means any painting or artistic work composed in
- 2 black and white or arrangements of color, including mosaics,
- 3 murals, stencil art, and other art media and techniques. Urban
- 4 art excludes:
- 5 (1) Painting or work placed on a structure that is erected
- for the sole or primary purpose of signage; and
- 7 (2) Graffiti as defined in sections 46-1.5(24) (C) or 577-
- 8 3.5(a), Hawaii Revised Statutes.
- 9 (e) The state foundation on culture and the arts shall
- 10 report to the legislature no later than twenty days prior to the
- 11 convening of the regular session of 2016 on the status of the
- 12 pilot program for the creation of urban art and shall submit its
- 13 findings and recommendations, including any proposed
- 14 legislation, regarding continuation of the program on a
- 15 permanent basis. The report shall also include recommendations
- 16 to reduce illicit graffiti.
- 17 (f) The pilot program for the creation of urban art shall
- 18 be repealed on June 30, 2016.
- 19 SECTION 3. This Act shall take effect on July 1, 2050.
