A BILL FOR AN ACT

RELATING TO HOMELESS PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness
- 2 continues to be one of the State's most significant and
- 3 challenging social problems. The number of homeless persons in
- 4 the State, estimated to be approximately six thousand on any
- 5 given day, is indicative of the limited shelter space available.
- 6 The legislature further finds that new and innovative
- 7 solutions are needed to address the homelessness crisis.
- 8 Oregon, for example, has adopted laws that authorize political
- 9 subdivisions to allow religious institutions to offer overnight
- 10 camping space for homeless persons living in vehicles.
- 11 Similarly, Santa Barbara, California, has instituted a program
- 12 that allows private organizations to use county-owned parking
- 13 lots to provide overnight sleeping space for homeless persons
- 14 with vehicles.
- 15 The purpose of this Act is to authorize the department of
- 16 human services, in consultation with the counties and public or
- 17 private homeless assistance programs, to develop temporary
- 18 nighttime parking lots to provide safe overnight locations for HB535 HD1 HMS 2013-1597-1



- 1 homeless persons who would otherwise sleep in their vehicles
- 2 parked on private or public roads or property. It is the
- 3 legislature's intent that this program supplement existing
- 4 policies and initiatives regarding the State's homeless
- 5 population.
- SECTION 2. Section 346-375, Hawaii Revised Statutes, is 6
- 7 amended to read as follows:
- 8 "[f][\$346-375[f] Temporary emergency shelter[.]; temporary
- 9 nighttime parking lots. (a) In addition to any other duties
- 10 prescribed by law, the department shall develop, in consultation
- 11 with the four counties, a procedure for identifying locations
- 12 that shall be used for temporary emergency shelters for homeless
- individuals and families. The department shall actively partner 13
- 14 with and monitor the efforts of the counties.
- 15 (b) Each county shall be responsible for partnering with
- 16 nonprofit organizations to locate, designate, and maintain the
- **17** areas that shall be used for temporary emergency shelters. The
- 18 designated locations may include private, county, state, and
- 19 federal lands.
- **20** (c) The department, in consultation with the mayor of the
- 21 applicable county and any interested public or private homeless
- assistance programs, may designate in each county temporary 22

- 1 in their motor vehicles and who would otherwise park overnight
- 2 on public or private roads or property.
- 3 The sum appropriated shall be expended by the department of
- 4 human services for the purposes of this Act.
- 5 SECTION 4. Statutory material to be repealed is bracketed
- 6 and stricken. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect on July 1, 2013.

Authorizes the designation of temporary nighttime parking lots in each county to provide safe overnight parking for homeless individuals who live and sleep in their motor vehicles and who would otherwise park overnight on public or private roads or property.
