BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 387-2, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "\$387-2 Minimum wages. (a) Except as provided in section 4 387-9 and this section, every employer shall pay to each employee employed by the employer, wages at the rate of not less 5 6 than: 7 \$6.25 per hour beginning January 1, 2003; (1)8 (2)\$6.75 per hour beginning January 1, 2006; [and] 9 \$7.25 per hour beginning January 1, 2007[-]; (3) 10 (4) \$8.25 per hour beginning July 1, 2013; 11 (5) \$8.75 per hour beginning July 1, 2014 and ending on 12 June 30, 2015; and 13 An amount adjusted in accordance with subsection (c) (6) 14 beginning July 1, 2015. 15 The hourly wage of a tipped employee may be deemed to (b) 16 be increased on account of tips if the employee is paid not less 17 than 25 cents below the applicable minimum wage by the employee's employer and the combined amount the employee 18

- 3 (c) On September 30, 2014, and on September 30 each year
