
A BILL FOR AN ACT

RELATING TO RENTAL MOTOR VEHICLE SURCHARGE TAX.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 251-1, Hawaii Revised Statutes, is
2 amended by adding a new definition to be appropriately inserted
3 and to read as follows:

4 "Car-sharing organization" means an organization that
5 operates a membership program in which its members are permitted
6 to use vehicles from the organization's fleet on an hourly basis
7 at hourly rates that include the cost of insurance and the cost
8 of the vehicle to the organization."

9 SECTION 2. Section 251-2, Hawaii Revised Statutes, is
10 amended to read as follows:

11 "**§251-2 Rental motor vehicle and tour vehicle surcharge**
12 **tax.** (a) There is levied and shall be assessed and collected
13 each month a rental motor vehicle surcharge tax of \$7.50 a day,
14 except that [~~after~~]:

15 (1) After June 30, 2012, the tax shall be \$3 a day, or any
16 portion of a day that a rental motor vehicle is rented
17 or leased[-]; or



1 (2) In the case of rentals made by a car-sharing
2 organization to its members the surcharge tax shall be
3 prorated at 12.5 cents per hour.

4 (b) The rental motor vehicle surcharge tax shall be levied
5 upon the lessor; provided that the tax shall not be levied on
6 the lessor if:

7 (1) The lessor is renting the vehicle to replace a vehicle
8 of the lessee that is being repaired; and

9 (2) A record of the repair order for the vehicle is
10 retained either by the lessor for two years for
11 verification purposes or by a motor vehicle repair
12 dealer for two years as provided in section 437B-16.

13 [~~(b)~~] (c) There is levied and shall be assessed and
14 collected each month a tour vehicle surcharge tax of:

15 (1) \$65 for each tour vehicle used or partially used
16 during the month that falls into the over twenty-five
17 passenger seat category; and

18 (2) \$15 for each tour vehicle used or partially used
19 during the month that falls into the eight to twenty-
20 five passenger seat category.

21 The tour vehicle surcharge tax shall be levied upon the tour
22 vehicle operator."



1 SECTION 3. Statutory material to be repealed is bracketed
2 and stricken. New statutory material is underscored.

3 SECTION 4. This Act shall take effect on July 1, 2020.
