BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 205, Hawaii Revised Statutes, is

9	commission deems necessary to mitigate adverse impacts of		
10	development on the surrounding community, within urban growth		
11	boundaries.		
12	(b) The commission shall convene in 2013, and every five		
13	years thereafter, and shall consist of:		
14	(1) The chairperson of the board of land and natural		
15	resources, who shall serve as chairperson of the		
16	<pre>commission;</pre>
