A BILL FOR AN ACT

RELATING TO HOMELAND SECURITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is an ever 2 increasing possibility of terrorist or other man-made threats 3 to: infrastructure critical to national security; local, state 4 and federal governmental entities; and the stability and 5 security of the citizens of Hawaii. The increasing 6 sophistication of terrorist groups, trans-national criminal 7 organizations, and others who would threaten the peace and 8 security of our state, greatly complicates our ability to 9 protect our citizens and prevent attacks. 10 The legislature further finds that state departments and
 - agencies are performing many missions and tasks to combat terrorism and support homeland security requirements without underlying statutory authority or enabling legislation.
- The purpose of this Act is to establish a homeland security
 office and supporting laws to provide a comprehensive program to
 protect our citizens, infrastructure, and government from
- 17 terrorism and threat of attack.

1	SECTION 2. The Hawaii Revised Statutes is amended by
2	adding a new chapter to be appropriately designated and to read
3	as follows:
4	"CHAPTER
5	HOMELAND SECURITY
6	§ -1 Policy and purpose. (a) Because of the existing
7	and increasing possibility of the occurrence of terrorist
8	attacks of unprecedented size and destructiveness, and in order
9	to ensure that preparations of the State will be adequate to
10	deal with such attacks, and generally to protect the public
11	peace, health, and safety, and to preserve the lives and
12	property of the people of the State, it is hereby found and
13	declared to be necessary:
14	(1) To provide for homeland security by the State, and to
15	authorize the creation of local organizations for
16	homeland security in the counties of the State;
17	(2) To confer upon the governor the emergency powers
18	provided herein; and
19	(3) To provide programs, in coordination with county
20	agencies, other state and federal agencies, and the
21	private sector, to educate and train publicly and
22	privately employed workers and the general public to
23	be prepared for attacks.

- 1 (b) It is further declared to be the purpose of this
- 2 chapter and the policy of the State that all homeland security
- 3 functions of the State and its counties be coordinated to the
- 4 maximum extent with the comparable functions of the federal
- 5 government including its various departments, and agencies of
- 6 other states and localities, and of private agencies of every
- 7 type, to the end that the most effective preparation and use may
- 8 be made of the nation's manpower, resources, and facilities for
- 9 dealing with any attack that may occur.
- 10 § -2 Definitions. As used in this chapter:
- 11 "Attack" means any attack or series of attacks by anyone
- 12 causing, or which may cause, damage or injury to persons or
- 13 property in the United States in any manner by the use of

- 16 hostile action.
- "County" means any of the political subdivisions including
- 18 the counties of Hawaii, Maui, and Kauai and the city and county
- 19 of Honolulu, but does not include the county of Kalawao.
- 20 "Director of homeland security" means the adjutant general,
- 21 pursuant to section 26-21.

- 1 "Facilities", except as otherwise provided in this chapter,
- 2 includes buildings and other structures, shelters, land, and
- 3 appurtenant materials.
- 4 "Homeland security" means a concerted effort to prevent
- 5 terrorist attacks within the United States; reduce Hawaii's
- 6 vulnerability to terrorism and attacks; and minimize the damage
- 7 and recover from attacks that occur.
- 8 "Mayor" means the senior elected official of the executive
- 9 branch of each political subdivision in the State of Hawaii, but

JUSTIFICATION:

Since the attacks of 9-11, the Department of Defense has taken on an ever-increasing role in homeland security, but there are no legal authorities or requirements for a homeland security office.

This bill will establish the Office of Homeland Security within the Department of Defense and outline the responsibilities of that office.

Impact on the public: The addition of the Homeland Security Office within the Department of Defense will provide greater security for the citizens of Hawaii. The office will be responsible for tracking and helping to protect critical infrastructure, and for coordinating homeland defense and homeland security plans with all entities in the state.

Impact on the department and other agencies:
Passage of this measure will establish the
Office of Homeland Security within the
Department of Defense.
