### A BILL FOR AN ACT

RELATING TO SALES OF ELECTRONIC SMOKING DEVICES TO PERSONS UNDER 18 YEARS OF AGE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 709-908, Hawaii Revised Statutes, is
2	amended by amending subsection (1) to read as follows:

## H.B. NO. 896

### Report Title:

Sales of Electronic Smoking Devices to Persons Under Eighteen Years of Age

#### Description:

Adds electronic smoking devices to tobacco as products that are unlawful to sell to or be purchased by persons under eighteen years of age; and requires the additional listing of electronic smoking devices to sales prohibition signage.

#### JUSTIFICATION SHEET

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO SALES OF ELECTRONIC SMOKING DEVICES TO PERSONS UNDER 18 YEARS OF AGE.

PURPOSE:

1) Prohibits the selling or furnishing of electronic smoking devices to persons under 18 years of age; 2) Prohibits persons under 18 from purchasing electronic smoking devices; and 3) Requires the listing of electronic smoking devices on sales

prohibition signage.

MEANS:

Amend section 709-908, Hawaii Revised Statutes.

JUSTIFICATION:

An electronic smoking device is any electronic product that can be used to simulate smoking in the delivery of nicotine or other substances to the person inhaling from the device, including, but not limited to, an electronic cigarette, electronic cigar, electronic cigarillo, or electronic pipe, or any cartridge or other component of the device or related product.

There is very little known about the long term health and psychological effects of the use of electronic smoking devices. The US Food and Drug Administration (FDA) cautions that such devices "may contain ingredients that are known to be toxic to humans, and may contain other ingredients that may not be safe." In 2010, federal courts ruled that the FDA may regulate the devices as tobacco products.

The FDA asserts that the ready availability of electronic smoking devices presents a serious risk of addicting new users, including children. As was the case with flavored cigarettes, now banned by the FDA, the cartridges in the devices come in a

variety of fruit and candy flavors that are appealing to young users in their teens. Electronic smoking devices present a compelling introduction to the sensation of smoking by allowing users, not only to mimic the tactile sensations of smoking, but also actually appear to blow smoke. These devices have the power to promote a physiological addiction to an addictive drug, as well as a psychological habituation to smoking.

Impact on the public: This bill prevents sales or furnishing of electronic smoking devices to persons under 18 years of age, bans persons under 18 years from purchasing electronic smoking devices and requires that electronic smoking devices be added to signs prohibiting sales of tobacco products to persons under 18. The public may recognize that promoting nicotine delivery system alternatives like electronic smoking devices could lead to the use of other tobacco products in youth, and this would be unwise from an overall public health point of view.

Impact on the department and other agencies:
The Department of Health would need to
monitor utilization, compliance, implement
public health education interventions, and
develop signage, as well as coordinate with
the tobacco sales-enforcement entities such
as county police departments.
