Vaccination Guidelines

Description:

Authorizes the Department of Health to adopt, amend, or repeal a list of specific vaccines and to adopt, amend, or repeal, as rules, the immunization recommendations of the United States Department of Health and Human Services, Advisory Committee on Immunization Practices, as they apply to the list of specific vaccines. This will ensure that immunizations required, and the manner and frequency of their administration, conform with currently recognized standard medical practices.

TITLE:

A BILL FOR AN ACT RELATING TO VACCINATION

GUIDELINES.

PURPOSE:

To authorize the Department of Health, without regard to the notice, public hearing, and comment requirements of chapter 91 and the provisions of chapter 201M, Hawaii Revised Statutes, to adopt, amend, or repeal as rules, the immunization recommendations of the United States Department of Health and Human Services, Advisory Committee on Immunization Practices (ACIP), including interim recommendations, as they apply to a list of specific vaccines. The list will be adopted, amended, or repealed pursuant to chapter 91. This authority will ensure that

immunizations required and the manner and frequency of their administration conform with currently recognized standard medical practices. The Department shall make the adoption, amendment, or repeal of ACIP immunization recommendations known to the public by giving public notice of the substance of the proposed rule statewide, by posting the full text of the rule on the Internet, and by publication at least once in a newspaper of general circulation.

MEANS:

Amend sections 302A-1162 and 325-32, Hawaii

Revised Statutes.

JUSTIFICATION:

National recommendations for vaccine administration are updated yearly, at minimum, by the ACIP and have resulted in discrepancies between current national vaccination standards and Hawaii's pediatric and school entry and attendance

requirements.

Impact on the public: Since chapter 11-157, Hawaii Administrative Rules (HAR),

"Examination and Immunization," was last updated in 2001, numerous changes to the timing and spacing of vaccinations have been recommended by the ACIP. These changes are not reflected in the current State pediatric immunization requirements and preschool, compulsory school, and post-secondary school entry and attendance requirements. This may result in students who, although they meet the school entry and attendance requirements specified in chapter 11-157, would not be considered "up-to-date" according to recommended immunization schedules because they are missing doses of currently recommended vaccinations (i.e., those not included in chapter 11-157). In addition, students who may have received vaccinations according to current ACIP recommended immunization schedules may be non-compliant with chapter 11-157 because of updates to recommended immunization timing or intervals that have not yet been incorporated into the rules. Currently, these students are placed on preschool, compulsory school, or postsecondary school provisional entrance status until the additional dose is administered and the outdated chapter 11-157 immunization requirement is met. Parents or quardians, as well as immunization providers, must pay for these additional vaccines, vaccine administration fees, and office visits in order for children affected by these discrepancies to attend school in Hawaii.

Impact on the department and other agencies:
Authorizing the Director of Health to adopt
ACIP immunization recommendations as they
apply to a specific list of vaccines, as
rules, without regard to the notice, public
hearing and comment requirements of chapter
91 and the provisions of chapter 201M,
Hawaii Revised Statutes, will allow for the
frequent, timely, updates necessary to
ensure concurrence between national vaccine
recommendations, in keeping with recognized
standard medical practices, and the school
immunization requirements.
