## A BILL FOR AN ACT

RELATING TO COMMITTED PERSONS ON FURLOUGH.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 353-17, Hawaii Revised Statutes, is
 amended by amending subsection (a) to read as follows:

The director or a designated agent may grant 3 "(a) 4 furloughs to committed persons with a minimum or lower security 5 classification in any correctional facility of the department 6 for the purpose of employment, social reorientation, education, 7 or training, or any other valid purpose as determined by the 8 director. Special out-of-state furloughs may be granted to 9 those already otherwise furloughed, at no cost to the State, 10 when death or critical illness or injury to the committed 11 person's immediate family including a reciprocal beneficiary, 12 occurs. Any committed person who is engaged in private employment, by contract or otherwise, not under the immediate 13 14 custody of the State shall not be considered an agent or 15 employee of the State. Any moneys earned from employment by 16 such person shall be used to satisfy [a restitution order and to 17 reimburge the State for the cost of room and board.] the 18 following obligations in the priority listed:

#### JUSTIFICATION SHEET

DEPARTMENT: Public Safety.

TITLE: A BILL FOR AN ACT RELATING TO COMMITTED PERSONS ON FURLOUGH.

PURPOSE: To add child support payments as obligations for inmates on furlough who are employed and delineates percentage of net earnings that shall be deducted to satisfy outstanding restitution and child support orders.

MEANS: Amend section 353-17(a), Hawaii Revised Statutes.

JUSTIFICATION: Child support orders are not included in statute as financial obligations for committed persons on furlough who are employed outside of the correctional facility. The proposed amendment will require thirty percent of net earnings be dedicated to outstanding child support orders.

> This proposal also specifies twenty-five percent of net earnings be deducted to satisfy outstanding restitution orders, which is in alignment with Act 139, Session Laws of Hawaii 2012. Current law is silent on what percent shall be deducted. In addition, it adds other court ordered fees and fines as obligations.

These percentages conform to those required for deductions as found in sections 353-22.6 and 353-22.8, Hawaii Revised Statutes.

<u>Impact on the public:</u> Child support and restitution orders shall be enforced, benefiting dependent children and victims of crime.
