1	WHEREAS, Hawaii is recognized as a global island leader in

5	the global challenge to build more sustainable economies, as			
6	Hawaii's people depend on imports for roughly 95 percent of			
7	their energy and 85 percent of their food, at an estimated			
8 .	annual cost of more than \$8 billion; and

10	WHEREAS, the Global Island Partnership (GLISPA), a			
11	partnership for all islands regardless of size or political			
12 13	status, works with island leaders around the world to conceive, launch, and implement inspiring and successful high-level			
13	commitments to island conservation and sustainable livelihoods;

17	WHEREAS, GLISPA invited Hawaii to join the Partnership in			
18	September of 2013, and make a high-level international			
19	commitment to sustainability because of the State's track record			
20	and aspirations to build a more secure, sustainable, and			
21	resilient island economy, community, and environment; and

23	WHEREAS, when Governor Abercrombie accepted GLISPA's			
24	invitation at a Washington Place reception for GLISPA			
25 26	representative Ambassador Jumeau from the Seychelles, he said,			
26 27	"Hawaii will join the Global Island Partnership to share Hawaii's successes and learn from other islands," and agreed to			
27 28	invite Hawaii's elected chief executives, legislators, and other			
20 29	leaders to join him in a statewide commitment to sustainability;

WHEREAS, Hawaii Green Growth is a voluntary partnership of 1 2 state, county, federal, business, and nongovernmental leaders from many sectors, including clean energy, local food 3 production, natural resource management, waste reduction, 4 climate change mitigation and adaptation, planning, green jobs, 5 and others, that is ready to support a shared statewide 6 7 commitment to sustainability; and 8 9 WHEREAS, drawing from experience from other international 10 commitments, key elements for an Aloha+ Challenge: A Culture of Sustainability -- He Nohona 'Ae'oia have been outlined, with 11 principles and targets based on current state priorities and 12 13 policies; and 14 WHEREAS, the Hawaii State Legislature has a proven track 15 record of supporting sustainability across economic, social, and 16 17 environmental sectors, including providing guidance to assure a sustainable future through the Hawaii 2050 Task Force and 18 19 Sustainability Plan established in Act 8, Special Session Laws of Hawaii 2005, and establishing sustainability as a priority in 20 the Hawaii State Plan under Chapter 226, Hawaii Revised 21 Statutes; and 22 23 24 WHEREAS, the Hawaii State Planning Act defines sustainability and provides guiding principles for the Aloha+ 25 Challenge, including: 26 27 Respecting the culture, character, beauty, and history (1) 28 of the State's island communities; 29 30 (2) Striking a balance between economic, social, 31 32 community, and environmental priorities; 33 Meeting the needs of the present without compromising 34 (3) the ability of future generations to meet their own 35 needs; and 36 37 Addressing the impacts of climate change and 38 (4) increasing climate change resilience; and 39 40 WHEREAS, the Governor, Mayors of all the Counties, and the 41 Chair of the Office of Hawaiian Affairs have expressed their 42 interest in accepting the Aloha+ Challenge; and 43

Resilience, National Invasive Species Council, Global 1 2 Island Partnership, and others; now, therefore, 3 BE IT RESOLVED by the House of Representatives of the 4 5 Twenty-seventh Legislature of the State of Hawaii, Regular Session of 2014, the Senate concurring, that this body endorses 6 and supports the integrated approach and six ambitious targets 7 of the Aloha+ Challenge to be achieved by 2030, which include: 8 9 (1) Clean Energy: 70 percent clean energy, including 40 10 percent from renewables and 30 percent from efficiency; 11 12 13 (2) Local Food: At least double the local food production with a goal of 20-30 percent of food consumed being grown 14 15 locally; 16 Natural Resource Management: Reverse the trend of natural 17 (3) resource loss mauka to makai by increasing watershed 18 protection, community-based marine management, invasive 19 species prevention and control, and restoration of native 20 species; 21 22 Waste Reduction: Reduce the solid waste stream prior to 23 (4) disposal by 50 percent, through source reduction, 24 recycling, and bioconversion; 25 26 (5) Smart Sustainable Communities: Increase livability and 27 28 resilience in the built environment through planning and implementation at the state and county levels; and 29 30 Green Workforce: Increase local green jobs and education (6) 31 32 to implement these targets; and 33 BE IT FURTHER RESOLVED that the Hawaii State Sustainability 34 Coordinator is requested to submit a report to the Legislature 35 no later than 20 days prior to the convening of the Regular 36 Session of 2015 on the launch of the Aloha+ Challenge, including 37

recommendations for promoting action and tracking progress on

the statewide sustainability targets; and
