- 16 shall be published statewide. Notice of public hearings
- 17 required by subsection (a)(2) shall be published county-wide in

PURPOSE:

Clarifies the notice requirements for the Hawaii Community Development Authority's public hearings required by section 206E-5.6, Hawaii Revised Statutes.

MEANS:

Amend section 206E-5.6(b), Hawaii Revised

Statutes.

JUSTIFICATION:

Currently, section 206E-5.6(b), Hawaii Revised Statutes, requires the Hawaii Community Development Authority to publish notice of its public hearings. However, the statute does not specify whether the Hawaii Community Development Authority must publish its notice in a publication with statewide or county-wide circulation in order to provide appropriate notice of its hearings. This proposal seeks to clarify that rule-making public hearings require statewide publication, and development plan approval public hearings require county-wide publication in the affected county.

Impact on the public: This amendment will allow the Hawaii Community Development Authority to publish notice of its public hearings to the appropriate audience. The Hawaii Community Development Authority will continue to publish notice on its website and send such notice to persons on its email list.
