### A BILL FOR AN ACT

RELATING TO LONG TERM CARE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Americans with
- 2 multiple, chronic health conditions and increased rates of
- 3 disability in old age are living longer now than in the past.
- 4 Furthermore, the aging of the population in Hawaii guarantees
- 5 that there will be a greater need for long term care in the
- 6 future. Between 2007 and 2030, the population aged eighty-five
- 7 and older, which has the greatest need for long term care, will
- 8 increase by almost two-thirds.
- 9 The legislature further finds that many people in Hawaii
- 10 have limited knowledge on long term care issues, and some of
- 11 what they know may be incorrect. For example, although long
- 12 term care is not covered by medicare or regular private health
- 13 insurance, a 2011 survey of Hawaii members of the Association of
- 14 American Retired Persons found that twenty-nine per cent of
- 15 respondents said they expected medicare to pay for their long
- 16 term care if needed.
- 17 The legislature additionally finds that unless people have
- 18 basic information about long term care, including the different

- 1 types and providers of long term care services, the statistical 2 risk of needing long term care, and the cost of long term care, they are unlikely to be motivated to establish long term care 3 4 plans or pay significant amounts of money for long term care 5 insurance. 6 The legislature also finds that a long term care education 7 and awareness campaign will educate people about their risks of needing long term care and motivate people to begin planning for 8 9 their potential long term care needs. 10 The purpose of this Act is to appropriate funds to the 11 executive office on aging of the department of health to 12 administer a public education and awareness campaign on long 13 term care and obtain an independent evaluation of the campaign. SECTION 2. (a) 14 The department of health's executive 15 office on aging shall conduct a long-term care education and 16 awareness campaign. **17** (b) The campaign goals shall include: 18 (1)Informing the public on the likelihood of needing 19 long-term care at some point in life;
- 20 (2) Educating the public on the risks of not planning for long term care and maximizing the length of independent living;
