RELATING TO EMPLOYER-UNION HEALTH BENEFITS TRUST FUND CONTRIBUTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. The purpose of this Act is to provide employer
3	contribution amounts for plan years 2011-2012 and 2012-2013 for
4	Hawaii employer-union health benefits trust fund health benefit
5	plan premiums for the employees of collective bargaining unit 10
6	and for state officers and employees excluded from collective
7	bargaining unit 10 pursuant to section 89-11(g), Hawaii Revised
8	Statutes, due to an impasse in negotiations on issues involving
9	the employer-union health benefits trust fund.

13	employees excluded from collective bargaining unit 10 for plan
14	years 2011-2012 and 2012-2013, subject to the applicable

TITLE:

A BILL FOR AN ACT RELATING TO EMPLOYER-UNION HEALTH BENEFITS TRUST FUND CONTRIBUTIONS.

PURPOSE:

To provide Employer contribution amounts for plan years 2011-2012 and 2012-2013 for Hawaii Employer-Union Health Benefits Trust Fund health benefit plan premiums for the employees of collective bargaining unit 10, and for state officers and employees excluded from collective bargaining unit 10.

MEANS:

By the Legislature determining amounts.

JUSTIFICATION:

The Employer and the United Public Workers are at impasse in collective bargaining negotiations, regarding contribution amounts for plan years 2011-2012 and 2012-2013 for Hawaii Employer-Union Health Benefits Trust Fund health benefit plan premiums for public officers and employees of bargaining unit 10. Pursuant to section 89-11(q), Hawaii Revised Statutes, the State's proposed contributions are being submitted via this bill. The approved budget for fiscal years 2011-2012 and 2012-2013 provides for 50 percent-50 percent employer-employee contributions. provides contributions consistent with the budgeted amounts.

Impact on the public: None.

Impact on the department and other agencies:
Setting these rates consistent with the rates agreed to by other bargaining units that have contracts in place will allow targeted savings in the budget for employer contributions for Employer-Union Health Benefits Trust Fund benefits to be achieved. Setting these rates the same as the rates agreed to by other bargaining units that

have contracts in place will provide equity among bargaining units for employer contributions for Employer-Union Health

Benefits Trust Fund benefits. This bill provides a mechanism to effectuate these

rates.
