TITLE:

A BILL FOR AN ACT RELATING TO THE OFFICE OF

ENVIRONMENTAL QUALITY CONTROL.

PURPOSE:

The purpose of this bill is to establish a special fund and fees to assist in funding

the activities of the Office of

Environmental Quality Control (OEQC) and the Environmental Council; support, modernize and maintain technology systems; support outreach, training, education, and research; and provide for the hiring of adequate staff under chapter 343, Hawaii Revised Statutes.

MEANS:

Add three new sections to chapter 341, Hawaii Revised Statutes (HRS), and amend subsection 341-3(a), HRS.

JUSTIFICATION:

General fund appropriations have not kept pace with the expanding workload of the OEQC which has resulted in longer wait times for public and private projects. Operations are further hampered by an outdated information technology infrastructure.

The establishment of fees, rule-making authority, and a special fund will provide a revenue stream that roughly correlates with demand and creates enhanced flexibility to meet evolving needs as sensitivity to environmental impacts grows.

Impact on the public: The proposed fees will not have a direct impact on the public. The fees will apply only to proponents of development projects that require review under chapter 343, HRS, the Hawaii Environmental Policy Act (HEPA).

Impact on the department and other agencies: This measure will generate funds to support OEQC statutory functions. Information management will improve and the funds will allow the OEQC to maintain its data-base system being requested in the OEQC's budget for the 2013-2014 fiscal year. State and county agencies will bear the cost for any agency project that requires review under chapter 343, HRS.
