A BILL FOR AN ACT

RELATING TO ECONOMIC DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part IV, subpart M, to be
- 3 appropriately designated and to read as follows:
- 4 "\$304A- Academy for creative media; established. (a)
- 5 There is established within the University of Hawaii the academy
- 6 for creative media, which shall be a system-wide, statewide
- 7 program administered by the University of Hawaii. The academy
- 8 for creative media shall offer courses and confer degrees as
- 9 deemed appropriate and as authorized by the board of regents,
- 10 including certificate programs and associate's, bachelor's,
- 11 master's, and doctorate degrees. The mission of the academy for
- 12 creative media shall be to emphasize narrative storytelling,
- 13 theories, skills, and applications across multiple platforms of
- 14 digital media and within a context of cultural and aesthetic
- 15 values by empowering students to tell their own stories of
- 16 Hawaii, the Pacific, and Asia through a unique program in
- 17 indigenous filmmaking.
