[(c)] (b) No conveyance used by any person as a common 1 carrier in the transaction of a business as a common 2 carrier is subject to forfeiture under this section 3 unless it appears that the owner or other person in 4 charge of the conveyance is a consenting party or 5 privy to a violation of this chapter; 6 (c) No conveyance is subject to forfeiture under this 7 [(d)] section by reason of any act or omission established 8 by the owner thereof to have been committed or omitted 9 without the owner's knowledge or consent; and 10 (d) A forfeiture of a conveyance encumbered by a bona [.(e)] 11 fide security interest is subject to the interest of 12 the secured party if the secured party neither had 13 14 knowledge of nor consented to the act or omission." This Act does not affect rights and duties that 15 SECTION 3. matured, penalties that were incurred, and proceedings that were 16 begun before its effective date. 17 SECTION 4. Statutory material to be repealed is bracketed 18 and stricken. New statutory material is underscored. 19 20
