A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii health systems corporation is the 2 fourth largest public hospital system in the nation and operates 3 public health care facilities that provide essential safety-net 4 hospital and long-term care services throughout the State. 5 legislature finds that changes in the health care industry and 6 implementation of national health care reform necessitate that 7 the Hawaii health systems corporation board of directors have 8 the necessary flexibility and autonomy needed for community 9 hospitals to compete and remain viable. 10 The Hawaii health systems corporation board currently 11 includes five regional chief executive officers who serve as ex-12 officio, voting members. The regional chief executive officers 13 have been instrumental in bringing additional expertise to the 14 board during its time of transition from a single corporation board to a multi-level board. In light of the successful 15 establishment of the regional system boards, the significant 16 challenges imposed by an ever-changing and complex health care **17**

environment, the time required to serve on the Hawaii health

- 1 systems corporation board, and the desire for additional
- 2 community participation, the legislature finds it appropriate to
- 3 replace the five regional chief executive officers on the board
- 4 with community members from each of the regional systems. The
- 5 regional chief executive officers will continue to participate
- 6 in the Hawaii health systems corporation's board meetings, along
- 7 with the Hawaii health systems corporation president and chief
- 8 executive officer, as invited staff.
- 9 The purpose of this Act is to improve accountability in the
- 10 health care system, support clear and consistent roles for all
- 11 regional systems, and create a more balanced multi-board tiered
- 12 system by replacing the membership of the five regional chief
- 13 executive officers on the Hawaii health systems corporation
- 14 board of directors with members who are appointed by the
- 15 respective county mayors from the counties that the members
- 16 represent.
- 17 SECTION 2. Section 323F-3, Hawaii Revised Statutes, is
- 18 amended by amending subsection (b) to read as follows:
- "(b) The members of the corporation board shall be
- 20 appointed as follows:
- 21 (1) The director of health as an ex-officio, voting
- member;

2	the island of Oahu [who], one of whom shall be
3	appointed by the Oahu regional system board[$ au$] and one
4	of whom shall be appointed by the mayor of the city
5	and county of Honolulu; and
6	$[\frac{(8)}{(7)}]$ One member who shall be appointed by the governor
7	and serve as an at-large voting member.
8	The appointed board members who reside in the county of
9	Maui, eastern section of the county of Hawaii, western section
10	of the county of Hawaii, on the island of Kauai, and on the
11	island of Oahu shall each serve for a term of four years;
12	provided that the terms of the initial appointments of the
13	members who are appointed by their respective regional system
14	boards shall be as follows: one of the initial members from the
15	county of Maui shall be appointed to serve a term of two years
16	and the other member shall be appointed to serve a term of four
17	years; the initial member from East Hawaii shall be appointed to
18	serve a term of two years; the initial member from West Hawaii
19	shall be appointed to serve a term of four years; the initial
20	member from the island of Kauai shall be appointed to serve a
21	term of two years; and the initial member from the island of
22	Oahu shall be appointed to serve a term of four years[-]; and

- 1 provided further that the terms of the initial appointments of
- 2 the members who are appointed by the mayors of the respective
- 3 counties shall be four years. The at-large member appointed by
- 4 the governor shall serve a term of two years.
- 5 Any vacancy shall be filled in the same manner provided for
- 6 the original appointments. The corporation board shall elect
- 7 its own chair from among its members. Appointments to the
- 8 corporation board shall be as representative as possible of the
- 9 system's stakeholders as outlined in this subsection."
- 10 SECTION 3. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 4. This Act shall take effect upon its approval.
