S.B. NO. 1364

A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$13,375,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2013-2014
5 for the purpose of financing capital improvement projects for
6 the University of Hawaii system as follows:

7 A. Magoon research facility

8 Plans and designs for the
9 renovation and expansion of the
10 Magoon research facility.

11 Plans and designs \$ 1,000,000

12 Total funding \$ 1,000,000

13 B. Lyon arboretum and botanical

14 garden
15 For the appraisal update to

SECTION 2. The appropriation made for the capital improvement projects authorized by section 1 of this Act shall not lapse at the end of the fiscal biennium for which the appropriation is made; provided that all moneys from the appropriation unencumbered as of June 30, 2016, shall lapse as of that date.

SECTION 3. The sums appropriated for the respective capital projects set forth in section 1 shall be expended by the designated expending agency for the purposes of this Act.

SECTION 4. This Act shall take effect on July 1, 2013.
