A BILL FOR AN ACT

RELATING TO CONDOMINIUMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to permit the real
- 2 estate commission to ensure compliance by enforcing any rule,
- 3 order, decision, demand, or requirement of the commission issued
- 4 pursuant to chapter 514B, Hawaii Revised Statutes.
- 5 SECTION 2. Chapter 514B, Hawaii Revised Statutes, is
- 6 amended by adding a new section to be appropriately designated
- 7 and to read as follows:
- 8 "\$514B- Enforcement action. In addition to its
- 9 authority under sections 514B-67 and 514B-68, whenever the
- 10 commission has reason to believe that any person has violated or
- 11 failed to comply with a rule, order, decision, demand, or
- 12 requirement of the commission issued pursuant to this chapter,
- 13 the commission may take whatever enforcement action is necessary
- 14 to ensure compliance with this chapter. A person who has been
- 15 found by the commission to have violated a rule, order,
- 16 decision, demand, or requirement may obtain a review thereof in
- 17 the appropriate circuit court within thirty days after service
- 18 upon the person of a written enforcement order."
