# A BILL FOR AN ACT

RELATING TO SMALL BOAT HARBORS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the study of
Hawaiian culture is required by the Hawaii constitution and is
vitally important to the people of Hawaii. Article X, section 4
of the Hawaii constitution states:

5 "The State shall promote the study of Hawaiian6 culture, history and language.

7 The State shall provide for a Hawaiian education program consisting of language, culture and history in 8 9 the public schools. The use of community expertise 10 shall be encouraged as a suitable and essential means 11 in furtherance of the Hawaiian education program." 12 The legislature also finds that for thousands of years, 13 native Hawaiians traveled the Pacific ocean in voyaging canoes. 14 The creation of the canoe itself was of an educational, social, 15 and spiritual character. The legislature further finds that, 16 given the importance of the canoe to Hawaiian culture, 17 opportunities to educate others about native Hawaiian canoes

18 should be supported by the State.

The purpose of this Act is to provide mooring space in 1 2 small boat harbors for native Hawaiian canoes used for nonprofit 3 educational purposes. SECTION 2. Chapter 200, Hawaii Revised Statutes, is 4 amended by adding a new section to part I to be appropriately 5 designated and to read as follows: 6 7 "§200-Native Hawaiian canoes; education. (a) In all state small boat harbors, the department shall accommodate the 8 mooring of native Hawaiian canoes owned or leased by a nonprofit 9 corporation, association, organization, or other duly chartered 10 11 entity operated for educational purposes. (b) Any owner of a native Hawaiian canoe accommodated 12 under subsection (a) shall submit to the department an annual 13 14 report describing the educational activities conducted during the previous year. The report shall include: 15 (1) A description of each educational activity; 16 17 The date of each educational activity; and (2) 18 The number of participants in each educational (3) 19 activity. The chairperson may adopt rules pursuant to chapter 91 20 (C) to implement this section." 21 SECTION 3. New statutory material is underscored. 22
