A BILL FOR AN ACT

RELATING TO ANIMAL CRUELTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that despite the
enactment of several animal cruelty offenses, local humane
societies, law enforcement agencies, and animal protection
groups continue to receive reports of dogs and cats being sold,
trafficked, or slaughtered for human consumption. Some of these
cases involve dogs and cats that were stolen or lost or acquired
via online advertisements for dogs or cats "free to good home".

8 In 2007, two defendants were prosecuted in Hawaii for 9 stealing a pet dog from the Moanalua Golf Course and killing the 10 dog with the intention of eating the animal. However, the 11 defendants were charged based on their admission to stealing and 12 butchering the dog rather than killing the pet to consume it 13 because the Hawaii penal code does not prohibit the slaughtering 14 or trafficking of dogs or cats for human consumption.

15 There are nearly a dozen states in the United States that 16 prohibit the slaughter of dogs or cats or the sale of dog or cat 17 products for the purpose of human consumption. The Philippines, 18 Taiwan, and Hong Kong also prohibit the sale or trafficking of 2014-0943 SB2026 SD1 SMA.doc

3	The purpose of this Act is to:
4	(1) Prohibit the slaughtering or trafficking of dogs or
5	cats for human consumption; and
6	(2) Amend the relevant portion of the definition of "pet
7	animal" as used in chapter 711, Hawaii Revised
8	Statutes, to mean any dog or cat, regardless of
9	whether the dog or cat was bred for consumption.
10	SECTION 2. Chapter 711, Hawaii Revised Statutes, is
11	amended by adding a new section to be appropriately designated
12	and to read as follows:
13	" <u>§711-</u> Cruelty to animals by slaughtering or trafficking
14	dogs or cats for human consumption. (1) A person commits the
15	offense of cruelty to animals by slaughtering or trafficking
16	dogs or cats for human consumption if the person intentionally:
17	(a) Slaughters by the person's self or in conspiracy with
18	another person a dog or cat for the purpose of human
19	consumption;
20	(b) Traffics dogs or cats or dog or cat products for the
21	purpose of human consumption; or

1	(c) Possesses dog or cat products for the purpose of human
2	consumption.
3	(2) As used in this section:
4	"Dog or cat products" means the carcass or part of a
5	carcass of any dog or cat.
6	"Sell" means the transfer of a dog or cat or dog or cat
7	products to another for the purpose of human consumption.
8	"Traffics dogs or cats or dog or cat products" means
9	breeds, raises, sells, offers for sale, exchanges, transports,
10	transfers, receives, trades, or barters dogs or cats or dog or
11	cat products.
12	(3) Cruelty to animals by slaughtering or trafficking dogs
13	or cats for human consumption shall be a misdemeanor."
14	SECTION 3. Section 711-1100, Hawaii Revised Statutes, is
15	amended by amending the definition of "pet animal" to read as
16	follows:
17	""Pet animal" means [a] <u>:</u>
18	(a) Any dog[τ] or cat[τ]; or
19	(b) <u>A</u> domesticated rabbit, guinea pig, domesticated pig,
20	or caged birds (passeriformes, piciformes, and
21	psittaciformes only) so long as not bred for
22	consumption."

SECTION 4. This Act does not affect rights and duties that
matured, penalties that were incurred, and proceedings that were
begun before its effective date.
SECTION 5. Statutory material to be repealed is bracketed
and stricken. New statutory material is underscored.

6 SECTION 6. This Act shall take effect upon its approval.

Prohibits the slaughtering or trafficking of dogs or cats for human consumption. Amends the definition of "pet animal" in chapter 711, HRS, to include any dog or cat rather than only dogs or cats not bred for human consumption. (SD1)
